ZANJA COMMITTEE.

The Report Adopted at the Meeting Yesterday.

At its regular weekly meeting, held yesterday, the zanja committee adopted the following report for presentation to the council on Monday next:

On petition No. 853, of Francis Bates, John Schenck et al., residents and property owners in the neighborhood known as Euclid hill, in Boyle Heights, asking that the zanja for its present crossing south of Louisiana avenue, be piped down Euclid street to a point 100 feet south of Willie street, with cement pipe.

Committee recommends that petition be granted and city engineer be instructed to make necessary preliminary surveys, plans and specifications, and submit all data necessary for bids.

On petition No. 975 of John J. Adams, Alex. Weill et al. asking that the pipe for irrigation, connected with zanja No. 9-R, be extended from the present terminus of the same on lot 3 of block 72 H. S., to such point as may be designated by the city engineer as the most suitable for irrigation purposes, on or near lot 4 of block 78 H. S., thus taking in about five hundred acres of land now without water. Recommend the same orders be made as in above petition.

Recommend that the petition of Mrs. Maria L. Ferguson in relation to water-well in zanja at corner of Flower and Seventh streets be granted, and the city engineer be instructed to make survey, plans and specifications, necessary for going away with the nuisance.

MANANA LAND.

Three Well-Known Citizens Return from Sonora.
