And further, that no person (or goods capable of retaining infection) from NORFOLK, or BALTIMORE shall be permitted to come to the City or County of Philadelphia, until they produce a satisfactory certificate of their being at least 15 days in a healthy state, from thence, under the PENALTY OF FIVE HUNDRED DOLLARS, agreeable to the 7th section of the Health Law, half of which will be paid to the informer on conviction. All proprietors of Stages, both by land and water, are desired to govern themselves accordingly.

And further, that no person (or goods capable of retaining infection) from the State of Rhode-Island, shall be permitted to come to the city or county of Philadelphia, until they produce a satisfactory certificate of their being at least 15 days in a healthy state from thence, under the penalty of Five Hundred Dollars, agreeable to the 7th Section of the Health Law, half of which will be paid to the informer on conviction. All proprietors of stages, both by land and water, are desired to govern themselves accordingly.
