an Enjoyable Affair.

All Classes of the Community Will Receive Full Protection from the Court-Not Proper to Kill a Man to Affect an Arrest-Long Petition Presented to Court in Behalf of the Woelkers-Cases Tried Yesterday.

Constable Joseph Woelkers and his brother, Special Officer John Woelkers who were convicted at the last term of court of having brutally assaulted and seriously injured John Schalasny of the South Side, for whose arrest they had a warraut, were called up for sentence before Judge Archbald yesterday.

Attorney M. W. Lowry made a plea for mercy and presented a long petition from citizens of the Eleventh ward asking for clemency. There was also a petition from seven of the jurors who convicted the men, asking that a light sentenced be imposed. In passing sentence Judge Archbald administered

The petition for clemency in this case is as trong one, and is signed by many well known and reputable residents of the Eleventh ward. In addition to the general character of the citizens who have signed the meltitions are signed. the petitions praying for clemency we have the signature of Martin Woyshner, the prosecutor in the case and that of Father Aust paster of the church of which the in-jured man is a member. I desire it to be dis-rinctly understood that all classes in this community shall receive full protection

NO OPPRESSION TOLERATED.

It has gone abroad that a certain class of people is subject to oppression by cer-tain officers of the law. Notice has come through the courts and through the pub-lic press that officers have used their official positions to extort money from others who have come over here more recently than themselves and are less acquainted with the manners and customs of the peo-ple of this country. When the case now under consideration was tried I charged the jury to take as favorable a view as possible of the defendants, one of whom was an officer of the law and the second of whom was called to assist in making the arrest. Indeed I would not look with disapproval on a verdict of acquittal of both

fendants. Yet here was a man who was very near-ly killed and for a time it was doubted that he could live. It is difficult to con-vince the average citizen of the necessity of killing a man in order to arrest him.
The jury viewed the matter in this way and I think their judgment was right, though my charge was favorable to the defendants. The jury fluds that Joseph Woelkers, the constable, ts guitt of aggravated assault and battery and John Woelkers of simple assault and battery.

THE PETITION RECEIVED. The punishment for aggravated assault and battery involves a one and imprisonment, but I can hardly dispense with both. But the defendant is an officer of the law, and there is a strong petition here from friends and neighbors of Mr. Woelkers. It is signed by some of the felow-countrymen of the injured man, and by Father Aust, the pastor of his church, and by the prosecutor in the case. I have laid all before my colleagues on the bench and the sentence I am to impose has met

with their approval.
