Scranton Adds Another to Its Victories Won the Past Week.

HAZLETON AGAIN THE VICTIM

At Philadelphia the Allentown Club Won with Ease—Harrisburg Pulls a Game Out of the Fire in the Ninth Inning with Lancaster—Reading-Pottsville Stopped by Rain with the Score a Tie—Standing of the Clubs. General Base Ball and Sporting News.

The week has passed of the second season in the State league. Allentown has passed the ordeal with six victories and no defeats, evidently endeavoring to duplicate Harrisburg's achievement of the first season. Lancaster is in second place and playing gingery ball as a result of the infusion of new blood into its team. Pottsville is in third place, with three victories and two defeats, while Scranton holds fourth position, with three victories and three defeats, as a result of her playing away from home the entire week. Reading heads the second phalanx, with Hazleton and Harrisburg a tie for sixth place, with the newly organized Philadelphia club bringing up the rear with one game won and five lost.

The Scranton club returns home with quite a good record, and by the time she leaves on her next outing we confidently expect her to occupy at least second place in the State league. At the same time it is also apparent that the club needs another good pitcher, for while both Hodson and Flaughan are pitching winning ball, yet there is no guaranteeing the possibility of one if not both of them becoming incapacitated by doing good work, if not being compelled to retire from the game entirely for a season, as accidents generally occur when we are least likely to be able to cope with them. It is to be hoped that the new pitcher, Yokes, of Shenandoah, will prove as capable as Hodson and Flaughan and be able to take his turn regularly with them.

AN EASY TRICK FOR FRED.
