## SOUTH GARFIELD AVENUE SEWER

Work Upon It Is Being Pushed Along as Rapidly as Possible.

The work of repairing the broken sewer on South Garfield avenue, which is being done under the supervision of the city engineer, is being rapidly pushed forward. The trench has been opened for about half a block and part of the old pipes laid bare.

In the old sewer twelve-inch pipes were used, but a fifteen-inch pipe will be laid instead. About the middle of the block a new sewer basin will be built, which will materially assist in carrying off the surface water. The sewer was broken early last spring by a settling in the mines beneath. At the Washburn street end of the sewer another basin will be built and what has been a great source of annoyance to the residents along the affected portion of the sewer will be removed.

## SUSPICIOUS DEATH.

John Phillips Found in an Unconscious Condition at the Cedar Avenue Bridge—Dies in Hospital.

"Jim" Phillips, a well-known local character, was found lying in a semi-unconscious condition on the bridge crossing the Roaring Brook by the North Steel mill, on Cedar avenue at 6:20 o'clock last night. Three hours afterward Phillips died at the Lackawanna hospital.

How a severe and half-healed cut on Phillips' face came there or what was the direct cause of death will not be known until after Coroner S. P. Longstreet's inquest has been held. Phillips was on several occasions in the insane department of the Hillside hospital. He had no fixed place of abode, but wandered from place to place. Last Wednesday night he engaged in a brawl on North Main avenue with a man named Evans. Phillips' wife lives on Swatland street, West Scranton.

The discovery of the almost lifeless body was made by a party of men when passing over the bridge. Patrolman Boland was near by, and Phillips was taken to the Lackawanna hospital.

Dr. Rank stated last night that Phillips never recovered consciousness. What caused his death, the hospital physicians could not say. Coroner Longstreet was immediately notified of the death, and the body was removed to the hospital morgue to await this morning's autopsy.

Phillips was apparently 40 years of age. Over his left eye is a cut one inch long, and extending with the eye brow. Another red welt on the left forehead and marks on the head show violence and possible foul play.
