Road Work Progressing.
 Sections Will Unite At Or Near Lewistown.

Last Sunday afternoon, through the courtesy of Mr. and Mrs. Chas. K. Beck, the manager of the CLARION was taken from Thurmont to Frederick over the State Road, a considerable portion of which is now being re surfaced.
 Beginning at Thurmont and before crossing the bridge, several wagon loads of stone were found thrown on the road bed. Persons not experiencing riding in an auto over a bed of stone cannot appreciate the sensation, but those in the car are always glad to get over such material.
 Three of such places were encountered on the pike and a fourth bunch on N. Market street in Frederick. Only at one place, and that for a short distance and with good side road the entire stretch, was the road closed to travel.
 A stretch of road perhaps a mile and a half long, beginning north of Lewistown and running through that place, has received very little attention thus far.
 Very little of the road has been completed, but automobiles can go at a fast clip almost all the way from Thurmont to Frederick on the newly built road. The widening and straightening of the road bed improves wonderfully the entire property of the State in this section.
 Two sharp turns in the road almost in front of the home of Dr. Wm. McPherson will be eliminated, a new road now being built across the land belonging to Catoctin Furnace property.
 While the trip was delightful last Sunday, the improvement will be wonderful when the road is fully rolled and oiled. This will probably all be done yet this fall.

Tax Rate Will Go Up.
 "That the tax rate in Frederick city will soar high next year is a known fact, now that it has been learned that the law enacted at the recent session of the Maryland Legislature exempting persons who own less than \$500 worth of household effects from paying taxes, will be applicable throughout the entire State. City Register Nicodemus stated this morning that the city tax rate will have to be increased considerably as it is said that nearly 90 per cent. of the people in Frederick city will be exempted from paying taxes on personal property as a result of the last amendment to the State tax law.
 "At present only those owning less than \$100 worth of personal property, as household effects, are exempted from paying taxes in Frederick city. In the county, those owning less than \$250 are exempted, but under the new law, there will be no distinction made between the county and city taxes in this respect. Of course, the county tax rate may have to be increased, too, but the law will not give exemption to as many county taxpayers as to city taxpayers, proportionally.
 "Some people claim that the new enactment will be a fine thing for the poor people who are taxed and on the other hand some say that it is putting too much of a tax upon the persons owning large amounts of property. The law is to go into effect in 1915.
 "The new law relative to the tax question, follows:
 "Beginning with and for the year 1915, and thereafter, all household furniture and effects in this State held for the household use of the owner thereof or members of his or her family shall be exempt from taxation for state and local purposes to the extent of \$500 of the assessed value thereof; but nothing herein shall be construed to apply to any furniture or effects held or employed for purposes of profit or in connection with any business, profession or occupation."

Aged Man Shot.
 After a carouse that lasted for several hours, during which both men tested with frequency a new concoction of intoxicating liquors, Tobias Trout, aged about 65, of near Ijamsville, picked up a shotgun and fired at Moses Thompson, about 77 years of age, as Thompson was leaving the Trout home. The shot was fired on Sunday evening about 4 o'clock. Later Thompson was found in an old shed some distance from the Trout home highly intoxicated, though conscious. His right side was peppered with shot, 94 being counted. Dr. Hopkins, of New Market, who attended the wounded man, states the wounds are not necessarily fatal. It appears that neither of the men know much about the shooting. Both are well known characters in that vicinity.

 The Philippine bureau of forestry has recently invited bids for the cutting of nearly 300,000 acres of choice timber-land on the public forests on the island of Luzon.


