

HOTTENTOTS ROUT GERMAN FORCES

War Lord's Forces in South-west Africa Defeated. CHIEF MARENGO'S DEFIANT Priest Placed Under Irons and Sent Forth in Irons Because Negotiations Failed.

CAPE TOWN, Oct. 13.—News of another serious reverse to German arms in southwest Africa reached here today.

It came in an official announcement which stated that the Hottentot Chiefs Marengo and Morris had captured the Jerusalem camp near Warmbad after severe fighting. Warmbad is a strong German base, as that the achievement of the Hottentots is noteworthy.

Killed at Jerusalem.

Lieutenant Surmand and six men were killed in the fighting at Jerusalem camp, while eight others were wounded. The Hottentots suffered no loss. They captured all the stock and stores.

Several Germans were captured, and after being disarmed were sent to General Von Trotha, the German military commander, and carrying a letter from Chief Marengo to the general which contained this defiant:

"The Hottentots are now in a position to take the offense and fight to the bitter end."

Kieplaats, a small garrison near Warmbad, was evacuated by the German garrison when they heard that Marengo was in the vicinity. They burned all the stores and retired toward Descondendam.

Priest Under Arrest.

Father Polopensky has been arrested and sent to Keetmanshoop, because of his failure to negotiate with Chief Marengo. The priest was heavily manacled after being taken into custody.

The garrison at Nikas has been strengthened by nine hundred men and a battery of artillery.

BRITISH RECEIVE BIG WELCOME AT TOKYO

TOKYO, Oct. 13.—The whole population of Tokyo turned out to greet Vice Admiral Sir Gerard Henry Noel, commander of the British Orient squadron, and his suite of officers. Such a welcome to foreigners has never before been extended in any Japanese city.

The foreigners were received by the mayor, and a program of athletic events arranged in their honor. Receptions and luncheons will take up the next two days.

COL. HENRY G. SHARPE GAZETTED FOR PROMOTION

Col. Henry G. Sharpe, U. S. A., was gazetted yesterday for promotion to the rank of brigadier general, and his assignment, for four years, to the duties of commissary general, was announced. In the latter capacity, as well as on the list of brigadier generals, he succeeds Gen. John C. Weston, recently made a major general.

General Weston, in the course of the next two weeks, will go to St. Louis to assume command of the northern division of the army, succeeding Major General Randall, retired.

KILLED BY FALLING BRICK

JAMESTOWN, N. Y., Oct. 13.—William Wade, a brother of Assemblyman Arthur C. Wade, was killed at Cherry Creek. While walking past a new building it brick fell, crushing his skull. He was sixty-two years of age.

Senator Heyburn Takes Issue With President

Objects to So Much Land in Idaho Being Set Aside For Forest Reserves—Proposes to Air Matter in Congress.

Senator Heyburn intends to air in Congress the matter of the forest reserves in Idaho, according to a special report issued by the Department of Agriculture, entitled "Forest Reserves in Idaho," and giving in full the correspondence that passed last spring and summer between the Senator, the President, and Gifford Pinchot, of the Department of Agriculture.

Last February the Senator protested to the President against the setting aside of so many forest reserves in Idaho, saying the State could not stand being deprived of so much of its territory, and claiming that much of the reserved land contained valuable mineral resources, which, by the proposed action of the Government, would be closed to the people of the country.

He attached to his letter a statement showing, he said, that the then existing reserves under Executive order amounted to 4,812,240 acres, and that the existing withdrawals of the land for the reservations and the suggested withdrawals brought the total up to the astonishing amount of 12,224,080 acres, which is nearly as big as New England and bigger than some whole States now in the Union.

Following this there were many letters exchanged, both by the President and Mr. Pinchot, some stating that Senator Heyburn had agreed to the proposed reservations in a conference between the three.

In the report a letter is also printed from Senator Dubois, saying that it appeared it was the people's duty to help the Government in the matter of the reserves, as they would be of great benefit to the country.

As a matter of fact, the Senator's protest did not delay the formation of the proposed reservations, and the correspondence ended with Senator Heyburn's declaration that he would air the matter before Congress.

DEPOSED BY CHURCH MORMON SEEKS REDRESS

As British Subject, John Scott, of Utah, Makes Known His Grievances to English Ambassador.

An interesting case was today brought to the attention of Sir Henry Mortimer Durand, British ambassador, by John Scott, of 192 Green street, Salt Lake City, Utah, who alleges he is a British subject.

Scott, who says he embraced the Mormon doctrine at Cardiff, Wales, in 1897, and settled in Utah, where he has since resided, addressed two letters, one to the British ambassador and the other to the President, under date of September 20 last.

In these letters he besought the good offices of the President and British ambassador (being still a British subject) to secure for him a hearing from the Mormon Church authorities at the October semi-annual conference in Salt Lake, where he proposed to bring charges against the Mormon leaders of exceeding their authority and oppressing himself and others in the membership.

He claimed the right to be heard on the ground that he has paid tithes, observed church regulations, and was entitled to a hearing under the community interest represented in him and others as proselytes by which they came into the church.

No official action has yet been taken in Washington on the case, but the facts were published in the Salt Lake Gentle newspapers, and Scott now alleges that he was excommunicated September 22 for having written the letters. He filed a second memorial today with the British embassy, demanding his rights from the church and invoking, as a British subject, the good offices of the ambassador. He asks not only that his own rights be respected, but that other British subjects be warned, inasmuch as Great Britain is a fruitful field for Mormon recruits.

SUIT FOR DIVORCE IN OTERO FAMILY

Sister of New Mexico's Governor Accuses Husband on Account of Authorship, it is Said.

DENVER, Col., Oct. 13.—Mrs. Mamie O'Bryan, sister of Gov. Miguel A. Otero, of New Mexico, has brought suit for divorce from Harry J. O'Bryan, a Denver attorney. She charges non-support, but it is understood that the authorship now in New York is the cause of the estrangement.

Mr. and Mrs. O'Bryan were married in New Mexico in 1890, and the wedding, because of the prominence of her family, was notable. She is a golf player and horsewoman and a member of the fashionable social set here.

Several months ago Mrs. O'Bryan took her son and daughter to Paris to educate them. She arrived from Paris a week ago, and it is said, found her husband in New York. She decided then to take action and came straight to Denver.

BLIND, SHE DID COOKING; WAS BURNED TO DEATH

CHICAGO, Oct. 13.—A blind woman was burned to death in her kitchen while her deaf old mother sat in an adjoining room, hearing nothing of the dying daughter's cries.

The victim was Mrs. Frances Harvey, a widow, forty-one years old, who had been blind from childhood, but had been accustomed to doing the cooking. She had placed the kettle on the gas stove, when the sleeves of her dress became ignited.

MORE INDICTMENTS RETURNED.

PEORIA, Ill., Oct. 12.—The third and last report of the grand jury, which is considering the N. C. Dougherty forgery and embezzlement case, will be made today, when about thirty additional indictments will be returned against Dougherty. These thirty indictments include the embezzlement of \$18,000 through the use of the name of A. H. Andrews & Co. of Chicago, and in all will approximate \$35,000.

HURT BY CANNON EXPLOSION.

LEBANON, Pa., Oct. 13.—Christian Nixdorf, seventy years old, of Lancaster, was fatally injured by the explosion of a brass cannon, which he, with other old veterans, was engaged in discharging along the route of the G. A. R. parade in Myerstown.
