

### HORSE CUTS CAPERS IN A CHINA STORE

#### Policeman Called to Arrest Sportive Equine.

#### CANDIDATES FOR CHIEF

#### Police Situation Takes a New Turn When Parties Are Mentioned as Webster's Probable Successor.

Police headquarters was notified about 8 o'clock this morning that a horse had entered the china store of the E. J. Miller Company, in lower King street, and was breaking up dishes, etc. Policeman Young repaired to the scene and took the horse in charge, it being the property of a Mr. Simpson.

#### Mentioned as Chief's Successor.

Who will be the chief of police of Alexandria, in the event of Captain Webster resigning or being removed by the board of police commissioners, is the chief subject of conversation in Alexandria at present. A number of names have been mentioned for the position, among these being that of Charles T. Goods, formerly a sergeant of the force; Capt. P. J. Murphy, of the Alexandria Light Infantry, and James F. Peyton, of the Washington Post. As Captain Webster has until June 1 to determine on his course in the matter, no selection will be made by the board of police commissioners.

#### Dies of Gunshot Wound.

Felonie Jackson, the colored man who was shot during a melee in a box car at Four-mile Run last week, died at the Alexandria Hospital about 6 o'clock last night. Raymond Giles, colored, who it is said shot Jackson, has had a trial and been acquitted. It being shown that he fired in self-defense.

### TERRANOVA GIRL'S SANITY UNDECIDED

#### Alienists Ask For More Time To Determine Question.

#### JUDGE GRANTS ADJOURNMENT

#### Josephine Breaking Down Under Strain of Remarkable Tests by Experts.

NEW YORK, May 28.—Unable to reach a decision as to her sanity, the commission appointed last Friday to inquire into the mental soundness of Josephine Terranova was not ready to report when court opened this morning for the resumption of the trial of the seventeen-year-old Italian girl, charged with the murder of her aunt and uncle. District Attorney Jerome asked for a further adjournment until tomorrow, stating that the commission would have by that time reached a definite conclusion. Counsel for the Terranova girl made strong opposition to an adjournment, but the motion of the district attorney was granted.

#### Girl Worn and Tired.

The girl was in court looking worn and tired out. Where there had been an indifference, the continued examinations of the alienists have broken her. The tortures of pins in the hands and face, and no end of experiments to test sensitiveness, have all but brought the girl to a state of collapse. These examinations have been made against her will. She told the commission that she was not insane, and when they made her an early morning visit and put her through the tortures, when her counsel was not present, she protested bitterly. The alienists in the case are getting \$250 a day.

#### Judge Scott's Statement.

Judge Scott, in granting the adjournment, said that it was contrary to the spirit of the law to try a person who is insane at the time of the trial and until he could get a true report of the condition of the girl, he would be unwilling to proceed with the case.

"When the girl was on the stand she was very intelligent to me," said Judge Scott, "but I am not an insanity expert, and might be deceived. I will adjourn the case until tomorrow."

### GREEN DOREMUS TRIAL IS BEGUN

#### Eleven Jurors Secured in Postoffice Cases.

#### MOTION TO QUASH IS DENIED

#### Defendants Jointly Charged With Conspiracy to Defraud the Government.

Former State Senator George E. Green, of New York, and Willard D. Doremus, of Washington, were placed on trial today before Justice Gould in Criminal Court No. 1 on indictments charging them with conspiracy to defraud the United States Government and bribe a Government official. The defendants are jointly charged on consolidated indictments, which were the outcome of the postoffice irregularities in 1902 and 1903. The indictments were returned October 5, 1902.

Before the work of impaneling the jury Attorney A. S. Worthington stated that he and John B. Stanchfield, of New York, appeared for Senator Green, and former Senator Thurston would represent Mr. Doremus. Mr. Thurston was not present and the court said "challenging" that he would assign counsel for Mr. Doremus, but did not do so.

#### Withdrew Original Plea.

Mr. Worthington interrupted the calling of the talesmen saying he would withdraw the plea of not guilty and file with the court a plea in abatement, a demurrer and a motion to quash. It was the same proceeding pursued in the former trial of Senator Green, said Mr. Worthington. United States District Attorney Baker demurred to each of the motions and was sustained by the bench. The selection of the jury was then proceeded with and in an hour the first half of the panel had been questioned and then followed the usual challenges, which ended by excluding fifteen of the talesmen, leaving eleven jurors in the box at the time recess was taken at 1 o'clock.

#### Consul Wynne a Witness.

Consul General Robert J. Wynne, of London, who is regarded as one of the most important witnesses for the defense, was not in court to answer to his name when the list of witnesses was called, but entered shortly after the proceedings had begun.

### Ena's Bride Cake Too Big for Palace Doors

#### Had to Be Cut Into Four Pieces and Put Together Again—Queen-to-Be Takes Name of Victoria.

MADRID, May 28.—The wedding cake for Princess Ena, which was made in London, arrived this morning. The cake is of such enormous proportions that it was impossible to take it inside the palace without cutting it. The cake was accordingly cut into four pieces, and an artist was engaged to put it together again after it had been taken inside the palace.

Princess Ena asked that the death sentence of two men doomed to the garrote today be commuted, the King promptly called a council of ministers and the merciful plea of the future Queen was granted.

Princess Ena has decided to take the name of Victoria after her marriage. It is announced that the government will proclaim a three-day holiday, from May 31, the wedding day. All public offices will be closed and the people will devote themselves to merry-making. Many towns have decided to give the princess' name to orphanages, hospitals and other buildings, the foundations of which will be laid on the wedding day.

The fact that the Queen-to-be has tried on her wedding dress has caused some comment among the superstitious, but Princess Ena laughs at superstition and is in love with her dress, which is one of the special presents from the King.
