

# WORLD'S BEST MEAT WILL BE AMERICA'S

Meat Inspection and Pure Food Laws Make Anything Else Impossible.

## DEPARTMENTS CO-OPERATE

Will Be a Wily Meat Packer Who Can Put Anything But Good Food on the Market.

When the meat inspection law and the pure food law are both in effect, he will be a canny farmer who gets any dubious meat products to the consumer. A double dose of inspection is now being organized for the products of the packers, which, in operation, will give a piece of bad meat about as much chance as an anarchist would have if he should walk down the main street of St. Petersburg with a bomb under his arm and a red flag flying at the mast-head.

There were fears on the part of the packers and the food manufacturers that a clash might take place between the authorities entrusted with the enforcement of the two laws. Instead of clash, there will be co-operation.

From Hoof to Can.

"From the hoof to the can" will be the jurisdiction within which Dr. Melvin's force of inspectors will follow the meat. Then they will turn it over to the minions of Dr. Harvey H. Wiley, who will trail it "from can to consumer." These gentlemen have conferred about their plans for handling the business, and the assurance is given that a modus vivendi has been arranged which amounts to an offensive and defensive alliance. They are especially anxious to demonstrate that two inspections are better than one.

It turns out that there is no real conflict of jurisdictions between the chief chemist and the chief of the Bureau of Animal Industry. The latter will boss the inspection of livestock on the hoof and during the process of manufacture, down to the point where the product becomes the subject of interstate commerce. Then Dr. Wiley will step in and assume charge. He will watch the progress of the product from the establishment where it is put up to the consumer.

Will Watch Establishments.

Dr. Melvin will attend to the sanitary and health arrangements of packing plants and their various departments in which the food articles are prepared, as well as to the inspection in its different stages. Dr. Wiley will be a good customer, investing in ample supply of samples in open market and subjecting them to the processes of his laboratory. There will be no dates on the cans, it is true; but Dr. Wiley will not take long to decide whether the lack of a date is a fatal defect in the law. When he finds any meat that isn't up to standard, he will have it condemned without delay, and it is confidently expected that this policy, vigorously followed, will very soon put an end to any tendency to keep meat products till they get showpew or pimento-filled. Microbes and bacteria and other "brutes" calculated to disarrange the inner works of the human mechanism will be driven out of circulation.

Make it Best in World.

Up at the top of this system of dual inspection will be the Secretary of Agriculture, with general authority over both branches of it, and a determination to harmonize any difficulties that may possibly arise. He is going to devote himself especially to the business of making American meat products notoriously the best in the world, confidently believing that this reputation can soon be established, and that, once established, it will immensely extend the market and increase the prices of American meats in foreign countries.

# BOYNTON SHAFT AT ARLINGTON



MEMORIAL TO GEN. HENRY V. BOYNTON.

Fitting Reminder, Recently Erected in National Cemetery Over the Last Resting Place of Beloved Citizen.

## Grave of Citizen and Soldier Marked by Imposing Monument.

An imposing shaft now marks the last resting place of Gen. Henry V. Boynton in Arlington Cemetery. The memorial has just been placed above the general's grave, and is a fitting reminder of the distinguished soldier. General Boynton's military career and his long service on the District Board of Education and in affairs materially affecting Washington made him a conspicuous figure in public life, and his death on June 3 of last year removed one of the best friends the District ever had.

## DANCE OF EPILEPTICS HELD IN LUXEMBOURG

Thousands of Afflicted Persons Flock From All Parts of Europe to Perform Weird Rites.

ECHTERNACH, July 6.—The weird "Dance of Epileptics," which takes place annually in this quiet little village at the extremity of the duchy of Luxembourg, near the German frontier, has once more been performed. Epileptics from all parts of Europe gathered here on a pilgrimage to the shrine of St. Willibrod, Abbot of Echternach. The procession begins at 8 o'clock in the morning, and though it has only a mile to go, it is all day getting there.

Occasionally one falls by the wayside and is dragged out of the way. Rich pilgrims employ healthy substitutes to take their places in the uncanny throng. Thousands of onlookers gather to watch the strange procession, and so impressive is it that many quite sane and healthy people fall under the influence of the hideous attraction and join the ranks.

The occasion was a particularly memorable one this year as the bones of St. Willibrod were moved from the old parish church to the new basilica, and a number of bishops were present to assist in the ceremony. Among those present was the Bishop of La Crosse, Wis.

## PLAYGROUNDS SUPERVISOR.

The shaft, which has just been added to the imposing monuments at Arlington, is made of Westery, Rhode Island, granite and stands five feet six inches high. Its base is four feet six inches, and in relief there bears the name "Boynton." A tablet cut into the shaft reads:

HENRY V. BOYNTON, Brigadier General, U. S. V. July 2, 1835, June 3, 1905.

Across the left hand upper corner of the shaft an American flag is gracefully draped. This is one of the most conspicuous features of the sculptor's work. The flag is executed in smooth design and is draped so that the lower part shows the stripes and the star ground rests just across the top of the rough hewn shaft.

## SAD TALE OF A DOG, HIS SHAKE AND A HIT

Man Sues Owner for His Damaged Face and Sprinkled Suit of Clothes.

PHILADELPHIA, Pa., July 6.—A new summer suit, a watering trough and a long-haired dog with a pugilistic owner made so much trouble for William M. Cherry, a young printer, of 806 Watkins street, that he spent some time in the hospital and is now suing Thomas Cameron, who has a tavern at Ninth and McKean streets, for \$5,000 damages. Cameron also owns the dog.

What happened was this: Cameron was bathing the dog in the watering trough in front of the saloon. Cherry was walking by in his good clothes. The dog got out of the trough, and as dogs will, began to shake himself. In doing so it sprayed Cherry's clothes liberally.

Cherry made a kick at the dog and missed it.

Cameron made a swing for Cherry and did not miss him.

This was all there was to it, except that Cherry charges the following injuries:

Cut lip (fifteen stitches).  
F. ruptured skull.  
Artery of left eye broken and sight may be injured.

For which Cherry asks \$5,000 damages.

## KILLED BY PITCHED BALL AS HE STOOD AT THE BAT

POTTSTOWN, Pa., July 6.—Struck by the second ball pitched in the morning game between Fleetwood and the Pottstown, Y. M. C. A., today, John Alting, of this place, was fatally injured. His skull was fractured, and he died several hours later in St. Joseph's Hospital. Young Alting had been playing with the Pottstown team, but was anxious to accompany the Y. M. C. A. to Fleetwood today, and his request was finally granted by Captain Shinehouse.

# Girl Stolen When a Baby Found by Grieving Mother

Pretty Oil City, Pa., School Teacher, Abducted in England When Two Years Old and Brought Here Is Now Nineteen.

OIL CITY, Pa., July 6.—When the prettiest of the teachers in Christ Church Sunday School took her place at the head of her class in the Fourth of July excursion all the little girls lisped "Good morning, Miss Holmes."

"Darlings, my name is Miss Holmes no longer," said the teacher to the little ones; "I find that's all a mistake. My real name is Miss Lee, so you'll all please call me that hereafter."

Miss Lee gathered the children about her knee and told them the story.

Tells Tale of Abduction.

She related how she was given away, as a child, to a cruel woman, who pretended to be her real mother, and who held her from her own mother and finally abducted her and fled to America.

She told, too, how the Rev. Dr. John Daws Hills, rector of Christ Church, had this week solved the mystery of identity and found in England the poor

sorrowing mother, who for seventeen long years had been advertising and searching in vain for her lost child.

Miss Lee has received two letters from her real mother in England. The one that came first reads in part as follows: "Through your rector I learn that you are my own darling child, Sydna Annie Lee. Oh, I am so glad, it seems as if my heart would burst. I knew you were alive; I felt it; I guess God has been true to me."

Dr. Hills is now working with all his energy to bring the mother in England and her long-lost daughter together.

Rector Now Girl's Guardian.

They have guarded her since February last, when by process of law she was taken away from Mrs. Holmes, who it is now disclosed had been only pretending to be her mother. The Rev. Dr. Hills is now officially constituted Miss Sydna Lee's legal guardian. He will assume the duties until such time as the young woman may be, for the first time in seventeen years, wrapped in her own mother's arms.

## PANAMA CANAL BONDS WILL HELP CIRCULATION
