After taking three straight from Cleveland on the local American League grounds, Washington made it five in a row by capturing a double-header in masterly style yesterday afternoon from Boston by 6 to 1 and 7 to 5.

COLLEGIANS BREAK ATHLETIC RECORDS

Four Men Exceed Pole Vault Mark Set by Dray.

PHILADELPHIA, Pa., May 30.—One world's record was equalled and two intercollegiate records were broken in the preliminary trials of the annual intercollegiate championships which were held yesterday afternoon on Franklin Field.

With the pick of the college athletes of the East participating, today's events were of a high order, and tomorrow's finals in the blue ribbon event of the college athletic year promises record performances.

So keen was the competition for qualification in the finals that the stars were pushed almost to their limit to keep the new men from beating them out. Undoubtedly the best performance of the day was the equaling of the world's records of 15-5 seconds in the 120-yard hurdle race by A. B. Shaw, of Dartmouth. His feat of duplicating the figures made several years ago by the marvelous Kraenzlein was received with much enthusiasm. In equaling these figures he broke Kraenzlein's intercollegiate record of 15-2 seconds.

With the preliminaries out of the way and the semi-finals yet to be run, experts figure that the intercollegiate championship lies between Pennsylvania and Cornell, with Yale and Michigan close up. Michigan and Yale did not come up to the expectations of those who follow the sport, some of the smaller colleges beating their entries out in several events. Pennsylvania practically did as that was expected of her men, and Cornell probably did a little better than was anticipated.

The preliminaries in eleven of the thirteen events were disposed of yesterday, there being no preliminary heats in the one and two-mile events which will be run today.
