SHARP RISE IN MARKET VALUES AS SHORTS COVER CONTRACTS. STREET IS HAPPY.

NEW YORK, May 16.—It was really a great stock market, but the public was just as much of it as ever. Not that the public showed any indifference, but the whole matter had come so suddenly, and the reverse action to that expected had taken the public by surprise that they simply looked on at the fluctuations and did not do any trading.

It was the shorts that made the session interesting. They had been caught in trouble, caught with another "unfavorable" decision of the "commodity clause," "Northern Securities" character, with a saving grace that really proved to be a great relief to the Street, and the bulls celebrated, with the confident bears of yesterday paid for the music.

Every customer's room in the city and, from reports, every branch office was crowded with people watching the action. They came, saw, and wondered, and may be expected to come back in a few days and try the temper of the market for long desired fliers.

But the Standard Oil people, after a gloomy early half-night, changed their minds when they heard the story of the saving clause, and even Standard Oil stock showed a splendid tone when the time came for trading in it, a 10-point advance following a 4-point decline.

It was 10:10 before the "Big Three" showed on the ticker and the watchers wondered. Small and moderate gains were made in the minor stocks, in the more important groups, but the impulsion of the group of watchers in every office was for the leaders.

Union Pacific advanced a gain of 1% on the opening, moved up from 17 1/2 to 18 1/2, and held its gain well. Reading made it 2 1/2, and added 1 1/2 to it, making a 3 1/2-point gain, and held it.

Practical everything in the list was strong. General Electric rose 2 points, Virginia Chemical 3 1/2, Utah Copper 1 1/2, and the list to 2 points. After the first rush of shorts the market cooled a bit, but still maintained a high degree of strength.

LOCAL SECURITIES WERE VERY QUIET, BUT HELD FIRMLY

Nothing Doing in Gas. Bonds Were in Fairly Good Request. Local Securities were very quiet. They did not respond to the boom on Wall Street for the reason that they are in no way affected by the ruling of the court.

There was no activity in stocks but bonds were in fair request. Gas was not on the sales record, this being two days in which the old favorite has only figured on the quotation record.

Steamboat 5's touched a new high at 10 1/2. Railway 4's were steady, and Columbia 5's 10 1/2. In the stock list Graphophone preferred sold at 23, Railway common at 24, and Standard preferred at 27.
