SCHENK IS DEFENDANT IN SUIT FOR FEES

Attorneys Ask Court to Compel Pork Packer to Pay \$45,000.

WHEELING, W. Va., April 14.—John O. Schenk, wealthy pork packer, whose wife, Laura O. Schenk, was accused of attempting to poison him and whose marital troubles have been in the courts for more than a year, has had more trouble added to his list.

District Attorney Bernard A. Antler, his private counsel, and O'Brien & O'Brien, for Mrs. Schenk, have entered a suit for counsel fees to the amount of \$45,000.

At the trial of the divorce case the court allowed Mrs. Schenk counsel fees. Neither there nor his counsel fees have been paid, it is said, and the three attorneys are asking the court to enforce payment. The case will have a hearing tomorrow.
