## 52,000 TO WITNESS GAME

Quaker City Cluttered by Gold Lace of Army and Navy Adherents.

PHILADELPHIA, Nov. 25.—A second lieutenant was left in command of the War Department in Washington today, and an ordinary "gob" seems to have been delegated to direct the destinies of the country's naval forces, while all the rank in both army and navy descended upon Philadelphia for the twenty-fifth annual tussle between the Cadets and the Midshipmen at Franklin Field this afternoon.

Admirals and generals are afoot everywhere in Philadelphia, and as for mere colonels and captains and majors and commanders—they are more numerous than plans for world peace.

Town Is Ticket-Crazy. Fifty-two thousand people, all that can be wedged into Penn's new stadium, will witness the colorful struggle at Franklin Field, and ten times as many will be there, judging from the mad last-minute scramble for tickets. The whole town is ticket-crazy; little else is heard in the lobbies and on the streets except "Got your's?" and "Where can I get a couple?" and "How much?"

This was to have been the year when the pasteborders were to be kept out of reach of the ever-present speculators. Yet the specs were on every corner today, and for every one there were at least two to take his wares at prices that would have made P. T. Barnum tear his hair. Fifty dollars a pair was not uncommon. Extra choice locations went at a great deal more.

The army was made a slight favorite in the early betting that was prevalent about the hotel corridors last night and this morning—although the edge of favoritism was thinner than a razor blade.

Exuberant and impetuous army people, believing that this is a West Point year after three straight navy victories, offered 6 to 5, and had their money snapped up almost before the color of it could be seen. The navy crowd came to Philadelphia expecting to find even money, and eager to take that, and they literally leaped at this 6 to 5 stuff. The betting was brisk about the hotel lobbies.

An Even Money Bet. To most unbiased football judges, today's meeting between the ancient rivals figures as pretty an even money bet as was ever offered. On form and past performances there is little to choose between the two.

## BURNS MAY PROBE KU KLUX

Cong. Rainey Announces Department Will Lay Facts Before Congress.

William J. Burns, chief of the Bureau of Investigation, of the Department of Justice will be called upon to furnish Congress with any information he might have regarding the activities of the Ku Klux Klan and their alleged meetings in the U. S. Capitol and the State, War and Navy buildings and any other additional information he might have regarding their use of other public buildings, either in Washington or any other city in the United States.

Time for Action, He Says. Congressman John W. Rainey of Illinois, who yesterday introduced a resolution calling for an investigation by the House and Senate of K. K. ceremonies reported to have been held in the Capitol and other buildings here, made this announcement today.

"The time has come," said the statement from Mr. Rainey, "for public officials to uphold their oath of office and to tear the mask from the faces and expose to the public those who are seeking to usurp the authority of our Government and, by their violations of our laws, under the guise of fraternal organizations, are becoming a disgrace to God, the nation, and our homes."

BIRMINGHAM, Ala., Nov. 25.—The finding of the body of another dead miner, a negro, in the depths of the No. 3 mine of the Woodward Iron Company at Dolomite, where a dust explosion snuffed out the lives of several score men Wednesday, causing serious injury to seventy-five others, brought the total number of dead this morning to eighty-six.

### "Get Out and Stay Out," Williams Tells Spouse on Hospital Visit.

"You get out of this room and stay out!" This was the greeting this morning of Francis M. Williams, commodore of the Corinthian Yacht Club, who is in a serious condition at Emergency Hospital as a result of bullet wounds, when his wife, Mrs. Agnes Williams, visited him today.

"I'll leave the room," she is reported as having replied, "but you'll pay for it." This remark was directed to Williams' secretary, who was sitting near the wounded man's bedside.

### Seek Wife's Arrest.

Shortly after she left the hospital the secretary, accompanied by Capt. Robert A. Williams, brother of the ill man, went to police headquarters to have a warrant sworn out for Mrs. Williams on the charge of making threats. The girl was told that warrants would not be issued until after 11 o'clock, and the captain and she left. This afternoon Captain Williams said he would renew his efforts to have Mrs. Williams arrested.

### Tale Of Trouble.

Williams and his brother had spent the evening at the Corinthian Yacht Club a few hours before the shooting. While on his way home in his automobile Williams saw the lights still on at his wife's home, 211 Third street northwest, and fearing that one of his children might be ill, he entered.

### Millionaire's Porter Held and Four Others, Including Woman, Sought.

By International News Service. CHICAGO, Nov. 25.—Joseph Denny, thirty, a porter in the automobile sales garage of Joseph ("Handsome Joe") Lanus was arrested when he came to work today by the police searching into the mystery of the business and love surrounding the murder of Lanus.

### Three Others Sought.

Questioned by the police, the porter told of a quarrel in the garage the night before last. He said a stranger was closeted in the office of Lanus while he himself was busy outside. He heard voices raised in loud argument and heard some mention of \$100 offered or demanded. He was held for further questioning.

At the same time the police were seeking three men with whom the automobile man was believed to have quarreled over a business deal a week ago. They had left a car with the intention of trading it in on a new one, it was said, and later attempted to retrace from their agreement. Lanus refused.

Also the police were searching for the woman whose full length chamois colored glove was found in an automobile a few feet from where Lanus' body was found.

### Liked Many Women.

Lanus died in a hospital a half hour after he had been found with the bullets in his back. The body was found by Fred D. Fugitt, a close personal friend of the slain man. Lanus was mortally wounded, lying beside his car, his foot resting on the running board and his body lying in a pool of blood. He died without making a statement.

### TURKS DEMAND ALLIES QUIT STAMBOUL BANKS

CONSTANTINOPLE, Nov. 25.—The Turkish Nationalist governor has requested the allies to withdraw the allied controllers from both Turkey and foreign banks, declaring that all officers are now subject to Turkish legislation.

### Free State Is Preparing for Week-End—MacSwineys Both Still Live.

By DANIEL O'CONNELL, International News Service. DUBLIN, Nov. 25.—The first outbreak of firing in Dublin following the execution of Erskine Childers, Republican leader, took place today.

Owing to the vigorous precautions taken by the Free State military authorities, the Irregulars, who were doing the shooting, were soon chased from their hiding places.

### Prepared for Reprisals.

Free State military authorities today prepared to cope with disorders over the week-end, launched by republican Irregulars in reprisal against the execution of Childers. For the next forty-eight hours troops will patrol the districts where trouble is most likely to break out.

Safeguarding measures were undertaken during the morning with a series of raids in the Kinsale district, where a number of men were arrested and arms seized.

### Plan Appeal to Red Cross.

Republican sympathizers said they planned a second communication to the International Red Cross, this one dealing exclusively with the execution of Childers. According to the Republicans, the accusation would be made that the Free State government violated the international agreement by executing Childers, "who was an ordinary prisoner of war, captured during civil conflict."

Although Eamonn de Valera promised to issue a statement from his hiding place outlining his reprisal plans for the execution of his chief aid, it had not made its appearance up to noon.

### Lies at Prison Gate.

Annie MacSwiney is in the ninth day of her hunger strike. Surrounded by a little group of friends and sympathizers, she lies once more upon a stretcher at the gates of the prison. She told the women gathered about her that she was as determined as ever to die of starvation unless allowed to see her sister, but she had about given up hope that the Free State officials would relent.

Mary MacSwiney, who has been on hunger strike in Mountjoy prison ever since her arrest, is in the hospital ward, but the prison authorities still refuse to give out any information as to her actual condition. That Mary MacSwiney was so near death on Thursday that the medical authorities gave her up was revealed in a message sent from the
