NEW YORK, June 27.—The heat today did not prevent thousands of Germans commencing their week of festivities. The streets in the different parts of the city are decorated with bunting and various devices of "wellkommen," and Germania Hall is profusely covered with flags of all nations, those of America and Germania floating prominently over all.

The arrival of the Chicago and western delegates to the Schutzenfest, made the scene of the city a turn out, consisting of about a hundred companies of the Schutzen corps, with a band of music, acted as escort to the reception committee. The western delegations were escorted through several of the streets to their quarters. On passing City Hall a battery of artillery fired a national salute. They brought the grand flag of the German League, which this evening was presented to the City of New York, with considerable pomp.
