At an interview sought by yourself, similar verbal reports from yourself and others, received and delivered to the official source, and the subject matter of your note, as then read to me, and as published in this morning's press, demanded, and has received, my earnest consideration. A critical examination of papers from the financial department seems the reason for your letter, as far as any therein suggested. In common with other city officers, I now stand before the public and our constituents charged with malfeasance in administration of the public trusts so long confided to my care. Legal proceedings, wherein such charges are made, and are to be substantiated if at all, are now on hearing before a fearless and just tribunal. My answer thereto is before the public, and my complete resignation is ready to be presented both to high court, our constituents, and to the citizens of New York at large. My counsel has urged, by my wish, a speedy trial and investigation. I am fearless of the result, and anxious for the procedure. During the many years of my administration in this office, I have not seen, and I fail to see now, any diminution of public confidence, and such fact would have been readily marked, nothing being more sensitive to general opinion than financial administration. I beg leave to inform you from your honor in thinking the robbery of my office creates any unexpected or sudden emergency. I am not apprehensive that either yourself or the community will suspect that I am a accomplice in this degradation. I am happy to assure you that it has effected no serious mischief, the archives of that department containing ample abstracts of all the stolen papers. Whoever planned or executed the crime has reaped

no benefit and inflicted no injury upon the public interests. Would not my resignation at this particular time, give advocates of partisan attacks upon the city government, just cause to believe me to be a pliant, not only to the Tammany leaders, but also passive in burglary, but as well as the charges now made in legal proceedings. So it seems to me. My official acts have been supervised and approved by your superior vigilance so far as my specialty attaches to some of the affidavits and the affidavits read in the pending litigation. You have adopted and vindicated those acts; you could not justify myself without so doing, consequently I do not perceive why my resignation should be asked in this hour. If tendered, it would have any just influence in opposing the popular clamor. Confident, therefore, in the steadfast good opinion of my friends, and in the ultimate judgment to be rendered by the courts, I cannot consistently with self-respect accept of your offer to resign, and this theory seemed to have acquired plausibility, when at a late hour last night it was announced that Mayor Hall had addressed the Controller a communication setting forth that the Mayor was constrained to conclude that the resignation of the Controller, as a condition of his retirement from the head of the finance department in order that some other person might be placed there by the Mayor, who will be enabled to investigate the affairs of the Controller's office, and restore public confidence. The Mayor adds in an affidavit that he cannot suspend any head of a department pending an investigation, and as charges should only be preferred to the Common Pleas, who alone can remove, after considerable time and trial he would be compelled to throw himself upon the generosity of the Controller, in the request made. In Wall street, during the afternoon, immediately a decline was produced in securities, in which the ring-leaders were especially interested. The city stocks also fell appreciably. A market feeling of distrust prevailed, and the city was generally depressed. The Controller was greatly dispirited, as he had been diligently engaged last week in the preparation of the accounts which the various vouchers would explain. Many of the Controller's friends claimed that the resignation had been abstracted by some enemy of the Controller's, merely for the purpose of creating the erroneous impression that he was privy to their abstraction. It is asserted that for some time past, Hall has been anxious to have the place of Connelly filled by some other person, and that a breach had occurred between the ring, which placed Hall and Sweeney in coalition as against Tweed and Connelly, and that an attack was made upon the latter two gentlemen in certain Democratic newspapers, and requests therein for their resignations were inspired by the former, who, in some newspaper article, were subjects of commendation rather than attack, and it was believed that if Connelly had made way for some other person, the Democratic party, whose malversations the documents in the Controller's office would reveal, could thus be screened, and a general hush-up probably secured all round.

The World says if the Controller disregard the demand of the Mayor, he will be before next night that a searching and persistent public indignation will make the city too hot to hold him. It adds that it may be his misfortune, not his fault, that this alleged robbery of his department occurred just at this critical juncture, and that the Mayor will be afforded an opportunity to appoint his successor.

A dispatch from Washington says that Mrs. R. H. Connelly on the 10th of last month transferred to her son five hundred thousand United States bonds.

The audience at the Supreme Court yesterday, to witness the proceedings of the Folger suit, was much less than that of yesterday. Upon opening the Court, Corporation Counsel O'Gorman commenced reading the affidavits which have been already published, bearing upon the cases of the defendants.

Every citizen has thus far failed to discover any clue to the theft of the Controller's office. It is said that duplicates of the stolen vouchers remain in the Controller's office and that
