The Recent Cloud-Burst at Pittsburgh.

The storm of Sunday night was a most extraordinary and fearful visitation to the people of Pittsburgh and vicinity. As the details come to light the magnitude of the disaster is increased instead of being diminished. Those who are familiar with the topography of Pittsburgh and its suburbs do not need to be told that its hills are as rough and forbidding, as sites for dwellings, as the hills which overshadow the city of Wheeling. Imagine Wheeling hill and Ohapline hill skirted with dwellings and shanties to the same extent that Grant's hill and other hills around Pittsburgh are skirted with all sorts of tenements. Imagine gulches and ravines intersecting unusual streets, and also sewers that were never constructed to carry off a tittle of the water that filled, overflowed and burst them last Sunday night. Imagine the momentum with which a vast and sudden deluge of water must escape from such hillsides as environ Pittsburgh. The rain that fell here Sunday night overflowed some of our streets in a manner never known before. And yet it was a mere shower as compared with the great cloud burst at Pittsburgh. The water fell in such torrents that the ravines were filled, the gulches were filled, the sewers were filled, and the water was dammed up and forced to seek vent in every direction. It zig-zagged here, there and everywhere, like a thousand serpents let loose, undermining houses in a moment, and tumbling them down and killing and maiming their unfortunate tenants. Some of these shanties were sent tumbling a hundred feet or more. The water escaped in such heavy sheets—such rivers as it were—from Grant's hill, that the Union depot was inundated to the extent of three feet and the tunnel which pierces the hill had four feet of water in it. Along one of the runs in the suburbs of the city thirty-eight bodies were found. The water rose in an instant, as it were, and came upon the people like the bursting of the Mill River dam. Indeed Allegheny county is clouded now with a gloom that is not exceeded by that which overhangs Mill River Valley in Massachusetts. The loss of life and property is fearful to contemplate.

VICTORIA WOODHULL, the free booter and free lover, is now in her glory. The BECKER business is meat and drink to her. She looks upon it as a vindication of her exposure two years ago. She says that when she waited on BECKER to get him to introduce her at Steiny Hall, on the well remembered occasion of her speech, that BECKER

"Said he agreed perfectly with what I was to say, but that he could not stand on the platform of Steiny Hall and introduce me. He said: 'I should sink through the floor. I am a moral coward on this subject, and I know it, and I am not fit to stand by the side of a woman who speaks what you know to be the truth. I should stand there a living lie.'"

He got upon the sofa on his knees beside me, and taking my face between his hands, while the tears streamed down his cheeks, begged me to let him off. He came thoroughly disgusted with what seemed to me the pusillanimity. I left the room under the control of a feeling of contempt for the man, and reported to my friends what he had said. They then took me again with them, and endeavored to persuade him.

Mr. Tilton said to him: "Mr. Beecher, some day you have got to go and introduce this woman, and win the radicals of the country, and it will break your fall." "Do you think," said Mr. B., "that this thing will come out to the world?" Mr. T. replied: "Nothing is more certain than that it will. Mr. Beecher, and this may be your last chance to save yourself from complete ruin."

Mr. Beecher replied: "I can never endure such terror. Oh! if it must come, let me know of it twenty-four hours in advance, that I may take my own life. I cannot, cannot face this thing."

THE STORM AT PARKERSBURG.—The Times of Monday says that the rain fell in torrents in that city Sunday night, and the wind blew a perfect gale. The Kanawha River swelled so suddenly that about \$5,000 worth of logs broke loose and floated into the Ohio. The lightning struck in four places in the city limits. W. P. MADDOX' house was attacked by the water from his kitchen door, which he opened, when a steady stream poured through the house for several hours. He had a deposit of mud on the floor about three inches thick.

What Tilton Says.

Tilton, in an interview with a Herald reporter, said that if the Plymouth Church Committee exonerated Mr. Beecher he should begin an action for divorce. This was a part of his language: "I am proud and have a very strong will. This is that which impels me on this course, unrelenting and inexorable apparently. I cannot hold my tongue. I have other proofs of the adultery of Mrs. Tilton than her confession, and those proofs most direct and positive." Mr. Tilton did not explain why he has never produced such proofs nor why the Plymouth Church Committee should not all have heard him say he had no other.

Beecher's "Confession" on Sale in Memphis.

MEMPHIS, July 27.—Considerable excitement was created here this afternoon by the appearance of an extra, purporting to be the confession of Rev. Henry Ward Beecher, admitting his guilt of the charges made by Theodore Tilton, and attempting to defend his action from a Biblical standpoint. The article was remarkably well written, and thousands of extras sold before the deception was discovered. A number of newsmen were arrested for selling them, and the police are endeavoring to find the author. The newsmen say they bought them from a man in Center alley.

Arrest of Tilton.

The sensation of the day yesterday in New York was the arrest of THEODORE TILTON on a sworn allegation of slander. It is intimated that the arrest is a device to bring the whole matter into court with a view of compelling the attendance of witnesses and eliciting facts that cannot otherwise be got at. It looks as if this was the case when we see Tilton released on his word of honor to appear to day and give bond. Possibly the idea is to bring Mr. FRANK MOULTON and Miss SUSAN B. ANTHONY into court by this process. They are two very important witnesses, and it is said that neither of them will testify in the case unless compelled to come into court. Miss ANTHONY's statement, as given second hand yesterday by Mrs. Cady Stanton, is very important. It puts another link in the chain and strengthens the TILTON side of the story. The only question is, will Miss ANTHONY confirm it under oath in a court of justice? If so, it will certainly neutralize Mrs. Tilton's recently published denial. But, after all, Mr. FRANK MOULTON is the one individual who, more than all others, holds the issue of life and death in this remarkable and mysterious affair in his keeping. If he confirms TILTON's statement, and it seems to be apprehended that he will, the case is ended for Mr. BECKER. It is either true or false that Mr. BECKER confessed his adence to Mr. MOULTON. TILTON says that Mr. BECKER confessed it to himself and also to Mr. MOULTON. It is easy for Mr. MOULTON to confirm or refute this statement. Would TILTON dare to make such a statement unless he knew, either from MOULTON or BECKER, or both, that it was true? Can we conceive him to be such an idiot as to imperil his case by running such a risk? Mr. MOULTON is described as being TILTON's friend, and as "a gallant, open-hearted, truthful man, who is incapable of double dealing." He is the man the public want to hear from. Meanwhile, the case is certainly looking darker for Mr. BECKER. The indirect evidence, such as CARPENTER's statement this morning and Mrs. STANTON's statement yesterday, cannot fail to impress the public unfavorably to Mr. BECKER. They are read and weighed in connection with his own letters—those ominous letters—the genuineness of which has not yet been denied by their reputed author. As Dr. BELLWIS says—

THE GREAT SCANDAL.

Mr. Woodhull interviewed. JENNIE JUNE'S TESTIMONY. NEW YORK, July 26.—The following statement, which is a summary of Tilton's forthcoming evidence and his complete case, is by Croley, of the Graphic, whose wife, Jennie June, intimately knew the women who have kept the scandal alive, though not of them.

The following points may serve to throw light upon the great scandal now agitating the community. In reciting them, I know fully whereof I speak:

First—Tilton was not acquainted with Mrs. Woodhull until nearly a year after the difficulty in his family. His acquaintance with her was due to the fact that it came to his knowledge that she was in possession of his family secret. His former life of that woman was written in the endeavor to placate her and prevent the publication of the scandal.

Second—The story of the scandal got to the public through the indiscretion of Susan B. Anthony. She was a guest of Tilton when the alleged discovery was made by Mr. Tilton. Her story is that Mr. Tilton came to her room one night complaining of the violence of Theodore, and she told her over fully at the breakfast table the next morning.

Third—The first person who communicated the alleged facts to Mrs. Woodhull was Mrs. Elizabeth Cady Stanton, who had received them in confidence from Miss Anthony, and of course they were told in the same way to all the family acquaintances of these two distinguished reformers.

Fourth—It is understood that Mrs. Woodhull has in her possession the letter written by a brother of Susan B. Anthony, a resident of Kansas, in which the whole story of the scene witnessed by his sister at the hotel in this city is told.

Fifth—Tilton really tried to save his wife from this scandal. He did not confess the facts even to his most intimate friends, and did all that a man could do to keep it secret until it was fairly driven to the wall.

Sixth—There is no doubt that at the time of this difficulty free divorce doctrines had a great deal to do with the catastrophe; that they were held in a measure by all parties to this unhappy scandal. The celebrated free divorce editorials in the Independent were written by Tilton subsequent to the discovery of the alleged scandal in his own family.

PITTSBURGH.

CITIZENS RELIEF MEETING.

PITTSBURGH, July 28.—A meeting of the citizens Relief Committee is now being held at Municipal Hall, Gen. J. K. Moorhead presiding. Speeches are being made by Mayor Fleming, of Allegheny, and subscriptions being taken, which will no doubt amount to a large sum. Mr. M. Stein, of Philadelphia, has authorized the Committee to draw on him for \$1,000.

THOUSANDS OF VICTIMS—FURNERAL SERVICES.

Thousands of people are visiting the scene of the great disaster to-day. In the Butcher's Run region it was found necessary to put on duty a company of the National Guards of the State to protect property and prevent the crowd from interfering with the workmen, who are clearing away the debris. The work of searching for the bodies proceeds slowly owing to the immense amount of wrecked material.

At noon to-day the funerals of the following victims took place, the burial services being conducted by the St. Vincent, St. Peter and St. Patrick Societies: Jas. and Louis Schaffer, and four children; Mr. Huber and wife, and Mr. Fox and wife. The bodies will be buried in the Uniondale Cemetery, where a lot which will hold twenty of the victims has been secured by the citizens' committee.

Measures will be taken to procure decent interment for all the victims. Excavations are going on for four children at the head of Butcher's Run. Five bodies have been taken out to-day, but none of them have yet been identified.

During the storm Sunday evening the Presbyterian church at Wilkingsburg was struck by lightning, but the congregation did not become aware of the fact till after the service, when it was discovered that the steeple had been destroyed.

In the Temperanceville district a large number of people are viewing the ruins.

The bodies of Mrs. Britter and Ida McVay were recovered about noon, and a body has been found floating at the ferry landing, which is supposed to be that of one of the sufferers.

FROM CHARTERS VALLEY.

Further reports have been received. On Sunday morning, July 27, a body was found on the banks of the Run this morning, with the scalp taken off and one arm gone. Half a mile above Bridgeville, Wm. Stratton, whose wife and five children were drowned, was found on top of a scycamore tree, where he had lodged. One thousand dollars was raised at a relief meeting in half an hour this afternoon. One thousand dollars was raised among the county officers for the relief fund to-day.

LIST OF BODIES RECOVERED.

Seven bodies are reported as having been found in Wood's Run this afternoon. Two of the bodies are unaccounted for in the list of the missing, and indicate that there must have been loss of life not yet reported. The following is an additional list of bodies recovered: Jacob Metzler and wife, Conrad Genzer and wife, James Schufler, his wife Maria and four children, Frederick Huber, wife and one child, Henry Leopold and four children, Archibald Arnold, Wm. Humbar, John H. Hager, and one child.

Men and teams are busy to-day all along the valley of the Run clearing away the rubbish and endeavoring to restore the streets to something like their former condition. Where Walnut street crosses Main street the cobble stones and pavement were torn up in the direction of the Run. One hundred men are to-day engaged in making repairs. Wm. Duffy, his wife and child and a lady visitor named Mrs. Rigby, had a very narrow escape. They heard the roar of the coming flood and fled to the hills, they had hardly crossed the threshold when the rushing water, like a mad dog, began to roar and burn down the stream with the crashing wrecks of other buildings.

The following is the latest recapitulation of the bodies found up to this time: Upper Allegheny District 32; Woods Run 9; Temperanceville 5; Chesapeake 1; Butcher's Run 1; total 57.

Reporters have made a visit to the district devastated by the late inundation, and have made a careful compilation of the names of the victims, so far as is known. The following is a complete list of the Allegheny dead, exclusive of Wood's Run. Some names have been duplicated in former reports. Jacob Metzler and wife, Conrad Genzer and wife, Mr. Geisler and wife, Mr. Fredericks and child, Mr. Schnappner, wife and four children, Mrs. Hager, Mr. Hoofnagle, J. S. Sherran, James Rixson, Mary Canlan and daughter, Harry Matlern, Charles Matlern, Emma Matlern, William Humbard, August Boelter, Emma Slaughter, Julia Roughton, Henry Hess, Minnie Hoover, Henry Schaffer, S. Matlern, Charles Matlern, and a baby named Schufler and seven other bodies which have not been identified, making a total of 57 bodies recovered in Butcher's Run district.

The latest from Temperanceville gives the following list of parties known to have been drowned. A large number of the bodies were recovered at this place, and were recovered so far as Wood's Run making a total of ninety-six bodies in all.

THE BEECHER SCANDAL.

An interview with F. B. Carpenter.

NEW YORK, July 28.—The Brooklyn Argus to-day prints part of an interview with Frank B. Carpenter on the subject of the Beecher scandal. Carpenter said he was first brought actively into the case by Beecher in May, 1873. Beecher sent for Carpenter, wishing him to come immediately to Brooklyn. Beecher had learned that Henry O. Bowen had reassigned to Carpenter the charges which he had formerly made to Tilton against Beecher, and which he had withdrawn in the private agreement, and that Bowen had said in the presence of Mr. E. S. Holton, of Milwaukee, and Carpenter, that he didn't wish them to understand that he had made a retraction. Beecher wished Carpenter to confront Bowen on these points.

It was also said that the triplicate covenant was to be made public. He went to Moulton's house; Beecher was not there, but Moulton said he wished Carpenter to go to Bowen's residence with Claffin and Moulton. They went, and Carpenter repeated in the presence of Bowen, Claffin and Moulton the statements made by Bowen to himself concerning Beecher. Bowen admitted all that was expressed in his statement, but that Bowen should have told these things after signing the covenant. Claffin was the person who induced Bowen to sign the covenant. Bowen said he protested against making the agreement public. Carpenter said to Bowen if the statements were made public, his name would be a qualified public denier, but if true he should stand by them. Bowen had said to Carpenter that Beecher had made a confession to him on his knees. Mr. Tilton and Moulton had been told by Beecher that this was a lie. Carpenter said to Bowen, "There is a direct lie between you and Mr. Beecher, and for one I want to know the truth." Claffin thought that Beecher ought to be present at this interview. Moulton went to his house for him, but did not find him at home, and Bowen expressed his willingness to meet Beecher the next day; Claffin refused to do so.

A law days afterwards Carpenter says, Claffin, who told him that Beecher had said "there isn't force enough in Brooklyn to draw me into a private interview with Henry O. Bowen. Carpenter says that in his business relations with Bowen they had frequent conversations regarding his guilt with Beecher. Bowen said Beecher's friends wanted him to sign a sweeping document declaring his charges against Beecher untrue, and he refused. Claffin then urged him at least to sign papers withdrawing his charges, and he consented.

Mr. Carpenter here repeated to the writer the substance of a conversation which took place between Beecher and himself on Sunday, June 1st, 1873, after service at Plymouth Church. We can only say that the statements which Carpenter says Mr. Beecher made that evening are true, of such importance and importance. Mr. Carpenter declares that he will not make public this conversation unless he is called upon to testify before a proper tribunal. It was during this interview Beecher told Carpenter that in case Theodore would make any statement, he would be ready to sign a statement, whereby he would be regarded by her during that period as not criminal or morally wrong, such had been the power of his arguments as a clergyman to satisfy her religious scruples against such violation of virtue and honor, therefore the deponent prays that the statement be apprehended and dealt with according to law.
