The People's Indictment of the Democracy and their Platform.

(From the Parkersburg State Journal.)

The following resolutions were unanimously adopted at the People's Convention held in this city September 10th.

They are powerful indictments of the Ring Democracy of the State, and the platform upon which the people propose to fight this campaign:

The Ring Democracy came into power in this State under the most solemn pledges of economy and reform.

Has it redeemed those pledges in any part or particular?

We charge that it has not, and if we fail to make good our indictment we accept the full responsibility of such failure.

The first act of the Bourbon Democracy after assuming power in our State was to call a Constitutional Convention, which has already cost the people \$250,000, and with a mass of legal technicalities that void of law, understanding or sense, in the place of a well arranged and carefully prepared code.

It has introduced contention into every department of our State government, compelling the Judiciary to enable the crime with partisan spite, the Executive to an open warfare to protect its prerogative, and compel corrupt officials to disgorge their ill-gotten gains, and covering our legislative records with a partisan strife that is shameful, wicked and disgusting.

It has given us a road law that belies a yeager and road surveys alike, and has given us a law that makes our public schools the shuttlecock for contending political factions.

It has given us a Homestead Exemption Law that leaves a tenant as thoroughly robbed as the man who traveled from Jerusalem to Jericho, and fell among thieves.

It has spent \$10,000 for a Christmas spree.

It has attempted to cover up and condone the crimes of a State official who has robbed the State of thousands of dollars in his printing peculations.

It has imposed taxes upon us that are burdensome and grievous.

It has destroyed our local self-government and placed the smallest minutiae of our police and fiscal affairs in the hands of court house clerks.

It has imposed upon us the County Court—an ancient and effete system that is burdensome, expensive and oppressive.

It has enacted laws that revive land suits and dispossess our honest yeomanry of their homes, where they were reared and their fathers before them.

It has, with a wasteful extravagance, appropriated money for moonshine railroad surveys for the exclusive benefit of the corporations and bankrupt non-residents.

For the truth of this indictment, we appeal to every page of West Virginia's history that has been written within the past three years.

Our platform is the total obliteration of all these things from the pages of our history.

The restoration of the old Constitution, or amendments to the new that will relieve it of this odium and oppression.

The repeal of the County Court system.

The restoration of townships and local self-government.

The enactment of a homestead law that is a homestead law, and not an intemperate swindle.

The separation of everything of a partisan character from our public schools.

The divorcement of the Capital question from the schemes of designing politicians, and its permanent settlement upon a basis that shall bring quiet to our State and a more healthful influence upon legislation.

The record that the Bourbon Democracy has made in one State during the past three years, and more notably, the legislation of the last session of our Legislature, has convinced the people that support of measures of reform must be sought elsewhere than in the ranks of Bourbon Democracy, and that to secure a real reform the honest voters of all parties must unite in the contest of the people versus the Ring Democracy.

For the enforcement of these views we invite the united action of all the people as opposed to the schemes of designing

politicians, cliques, rings and packed conventions, promising to withhold our support from any nominee or candidate who will not pledge himself to the support of these propositions unequivocally and without mental reservation.
