FOREIGN NEWS. England, Austria and Russia Preparing to Divide the Turkey.

Germany Not in the Ring, but May Have Something to Say. Russian Disasters Continue in Asia.

WAR NOTES. Russian Retreat. ERZURUM, July 10.—The Russians have retired from the neighborhood of Erzurum, and are marching toward Alexandropol. Without fighting, Mukhtar Pasha has entered Kara.

It is officially announced that the Russian left wing has been driven across the Russian frontier, pursued by Ismail Pasha. A detachment of citizens of Kara visited Mukhtar Pasha.

Constantinople, July 10.—A decree has been issued ordering the creation of a National Guard at Constantinople, consisting of six battalions, which will be formed immediately.

It is said that Greece intends purchasing some Danish men-of-war. ERZURUM, July 10.—Mukhtar Pasha has effected a junction with a part of the garrison of Kara at Thivalkoyka, three miles from the fortifications.

The Russians continue to retreat on Kurukdara. Ismail Pasha is at Mossomoa, three miles from the frontier. Gen. Terpakoff is occupying a position on the frontier.

BRUSSELS, July 10.—The Russian telegraphic agency has issued a statement, admitting that an alliance between Roumania and Serbia is not exactly impossible. It asserts, however, that such an alliance could not in any way affect good relations between Austria and Russia.

Gen. Semika telegraphs from Olessa that a Turkish fleet has commenced bombarding Euphrates. BUCHAREST, July 10.—The Prince and Princess of Roumania left here this morning for the headquarters of the Roumanian army at Krajova.

The Turkish monitor, which is ashore at the mouth of the Danube, remains firmly fixed. Her crew has been taken to two Russian vessels.

CONSTANTINOPLE, July 10.—Abdul Kerim Pasha has asked for 60,000 more men. It is probable that both he and Ahmed Eyoud Pasha will be superseded by Sultan and Mehmet Ali Pasha.

Mohamed Ruchdi Pasha, ex-Vicer, is charged with the supreme control of military affairs. The object of the appointment of the latter is to secure the acquiescence of the people if further resistance should be found useless.

VIENNA, July 10.—Specials from Asia state that in the Ardahan district, on June 23, the Russians pillaged 11 villages and killed 50 people on the pretext that they had fought against them.

On Friday last Gen. Terpakoff reported in Ruchdi Pasha's territory. His force marched 40 kilometers daily. It is believed to have lost all of its war materials.

A special from St. Petersburg states that 12,000 infantry from Saratov are now proceeding to Armenia by forced marches.

BERNESE, July 10.—A correspondent telegraphs that the Council of Ministers have decided that the Roumanian army shall assume the offensive. It is reported that General Cernuschi, Minister of War, will take a command in the field.

PARIS, July 10.—The radical newspaper Le Peuple was seized to-day for accusing the government of mediating a coup d'etat.

The Moniteur continues to bitterly censure the audacious intrigues of the Bonapartists. The organ of the Conservative Union says: Should the election result in a radical victory there would be a formidable crisis, another dissolution and possibly renewed the revolution.

RUSSIAN AND BISMARCK.—A Difference of Opinion. BERLIN, July 10.—At their last interview Lord Russell informed Prince Bismarck that England would under no consideration whatever suffer the Russian occupation of Constantinople. Prince Bismarck replied that he considered the occupation of Constantinople the best way to obtain the purposes for which the war was commenced.

PAN PRESBYTERIAN COUNCIL. EDINBURGH, July 10.—The Pan Presbyterian Council has adopted an address to the Queen signed by 233 representatives, commissioned by forty-nine Presbyterian churches in 25 separate countries.

ENGLAND. Blockade Not Binding. LONDON, July 10.—The British Government has informed the Porte that the blockade of the Black Sea is not binding, being ineffective.

SPAIN. Movements of Grant. COLOGNE, July 10.—Ex-President Grant left to-day, proceeding up the Rhine. He will be received in Frankfurt on the main to-morrow afternoon by a committee headed by the American Consul, and on Thursday a dinner will be given in his honor.

CAPTURED. LAMBERTVILLE, N. J., July 10.—Harry Van Eula, for whose arrest the Great Army of the Republic offered a reward, and who was charged with so cruelly mistreating a soldier's orphan that it died, was captured here to-day and lodged in jail.
