THE TRANSIT OF MERCURY.—The transit of Mercury, which occurred yesterday, was looked forward to with much interest by the astronomical world. His accurate observation being of special importance as regards the question whether the result of Le Verrier, that the motion of the perihelion of Mercury is much greater than that due to the action of the known planets, is really correct.

THE transit being visible here, Dr. E. Worthen put his large telescope in position on the top of his house, and made careful observations during the day. The first external contact occurred, in astronomical reckoning, May 5, 22h. 4m. Washington mean time—that is, four minutes past 10 o'clock yesterday morning.

TRANSIT OF MERCURY are much more frequent than those of Venus, the average interval being less than ten years. Thus yesterday's transit will be followed by others in 1881 and 91, while after the transit of Venus in 1882 none will occur until 2004.
