VERDICT OF THE CORONER'S JURY.

Young Nutt Still in Jail—Public Sympathy. With Him the Excitement Abating—Dukes' Remains Removed to His Mother's Home. A Very Lively Fiscal Proceeding.

PITTSBURGH, June 14.—A special from Uniontown, Pa., to the Chronicle says: In the room of the Jennings House where Captain Nutt met his death, to-day lies the mangled body of the young man, who was killed by the bullet of a man named Dukes, who only since Christmas last straddled the streets of Uniontown a living monument of outraged justice.
