CONVENTION ECHOES

OF THE GRAFTON AFFAIR.

The Seceders and Their Conference—Their Idea of the Future—Views on the Third Party Action—The Republican Party Believed and Prohibition Hart.

In the INTELLIGENCER'S review of the Grafton Prohibition Convention the name Lively was inadvertently used for that of the Rev. W. H. Wiley, of Marion county. The slip, however, was not inappropriate after all, for Mr. Wiley took an unconqueredly lively part in the proceedings of that now historic body. One of the most earnest Prohibitionists in West Virginia, one who never lets slip an opportunity to advance the cause so dear to his heart, Mr. Wiley was one of the first to detect that the Grafton Convention had been set up in the Third Party interest; he was the first man on the floor to sound the note of warning; it was he, who moved that the delegates who opposed a Third Party, be allowed to retire from the proceedings of a convention which already had determined to do a thing which he could not endorse. The other element did not understand the full purport of this motion or appreciate the rose to appearance, however, his motion was chosen most retire, the convention having no right to hold them. This fine sarcasm was lost on the equally determined men who afterwards pulled out and left the Third Party to gather up the fragments.

Rev. Dr. Dix, also of Marion county, was another of the potent influences against a Third Party. His quiet, dignified manner, his incisive language, his known devotion to the cause, commanded for him the attention of the Convention, whenever he chose most retire, the convention having no right to hold them. This fine sarcasm was lost on the equally determined men who afterwards pulled out and left the Third Party to gather up the fragments.

When it was decided that the Anti-Third Party men should leave in a body the Rev. B. B. Evans, a bright young Methodist Protestant clergyman at Grafton, extended a public invitation to the seceders to meet in his church. This gave rise to the impression that the meeting did not take place in the church, and that the seceders were gathered elsewhere for the proceedings of that gathering from their own imagination. In writing history it is well to be accurate about it. The seceders were in a room in the Arlington Hotel, which was very full. It was an informal meeting, and the Hon. Francis Smith, of Marion county, consented to act in that capacity. There was no secretary, there were no minutes taken, and so there is no record of the proceedings of this meeting, one of the few of formal action, the general feeling was in favor of organization under the auspices of the National League for the Suppression of the Liquor Traffic, with the Rev. George E. Hite, of Wheeling, as Vice-President of this organization for West Virginia.

The men who took part in this conference did not hesitate to express their disgust at the Third Party movement, and they have known that they were doing so. They were free to denounce as tricksters who had set the convention up for a purpose, and the galleons who had gone in with them so easily deceived to be of service to any party.

AN OLD STAGER'S VIEW.

A venerable gentleman whose life has been devoted to the temperance cause has been invited to the INTELLIGENCER in this way: "History will record the lamentable fact of the ill-considered management of a finger-numbered handful of Third Party politicians in the disruption of the West Virginia State Temperance Society. The State Temperance Society, which was organized by Parkersburg, voted squarely not to act in concert with the National Third Party politicians, which held its convention at Pittsburgh about the same time. Money was paid and subscribed liberally for the purpose of maintaining the temperance cause, and the State Temperance Society was organized in running the State Temperance Society and sustaining Rev. J. Warner, State Temperance Lecturer, and his paper, the Freeman. The funds invested have been illegitimately employed to some extent to back up the Third Party movement, the outcome of which was revealed in the Grafton Convention of 1885. Had the call for the annual meeting been made judiciously and squarely stated that an effort would be made to organize a Third Party, delegates would have been called, and in a fair issue would have been called by the decision.
