

STOPPED BY SNOWDEN.

Homestead Strikers Prevented from Further Demonstration of

JOY OVER M'LUCKIE'S RELEASE.

The Officer Sent to Carry Out the Order Shows Great Diplomacy, Presence of Mind and Good Sense, which Probably Averts a Disastrous Conflict--The Strike Situation--McLuckie is Released on Bail--All Quiet at Homestead.

HOMESTEAD, PA., July 20.—The sensation to-night in Homestead was a sudden stop which General Snowden put upon demonstrations in honor of Burgess McLuckie, whose release on bail to-day seemed the cause of as much rejoicing as if the big strike had terminated in a victory for the men.

A battery of artillery, three troops of cavalry and two companies of infantry, all full armed and accoutered, were held in readiness on the hillside to post down upon the strikers at a moment's notice, if General Snowden's order had met with the slightest resistance.

Capt. John Gerbich, of Chambersburg, with Company C, Eighth regiment, numbering thirty-five men, brought the order, arriving at Burgess McLuckie's house just when the strikers, fully fifteen hundred strong, with bands playing, the town council in carriages and the stars and stripes floating proudly over the labor magistrature of the borough, marched up the street from the depot.

Gen. Snowden's order was a verbal one to the provost marshal, Col. Green, and was brief but decisive: "Stop those proceedings," meaning the street parading in the town, and speechmaking expected to follow.

M'LUCKIE OUT ON BAIL.

The Judge Holds that He Should Not Be Held for Murder in the First Degree.

PITTSBURGH, Pa., July 20.—The second skirmish in the legal battle between the Carnegie Steel Company and the strikers was begun this morning before Judge Magee, when the application for the release of Burgess John McLuckie was called up.

Shortly after 9:30 o'clock Judge Magee came into court and a few minutes later Messrs. Kolb, Patterson and Beck, counsel for the prosecution, arrived, followed by Attorneys Cox and Brennan, representing the defense.

CURSED BY WOMEN.

The Militia Routly Abused--Increasing Bitterness.

HOMESTEAD, Pa., July 20.—Except for women cursing the militia, Homestead was in a death-like quiet this morning and throughout the night.

It was suggested that the announcement by General Snowden, that contrary to widespread expectation the troops would not be withdrawn until the existing difficulties in Homestead were settled had more to do with a growth of dislike for the militia than had any alleged despondency.



At noon everything was quiet about the mill. The strikers are anxiously waiting to see what will be done tomorrow, when the date for the old men expires.
