TARIFF AND FARMERS. Benefits Derived from Protection to Agricultural Products.

THE CANADIAN COMPETITION. With the New York Farmers Greatly Lessened - What the Official Returns of Imports Show - Figures That Conclusively Knock the Bottom Out of Democratic Theories.

Special to New York Tribune. WASHINGTON, D. C., Sept. 10. - "The farmer not only derives no direct benefit from the tariff, but is oppressed by it."

A careful examination of the official returns of imports shows that about 90 per cent of the agricultural products brought into the United States from the Dominion of Canada find entry at the ports of Buffalo, Cape Vincent, Champlain, Genesee, Niagara, Oswego, and Oswego—all in the state of New York.

Those returns also show that during the year ended June 30, 1890, the imports of the principal agricultural products into the United States from the Dominion of Canada amounted to the handsome sum of \$14,441,914.

Despite the increase in rates of duty the imports of sheep increased from \$1,208,752 to \$1,336,871; of oats, from \$6,755 to \$6,928, and beans and peas, from \$630,298 to \$716,000.
