THE UNIVERSITY.

Attendance This Year Expected to Reach Three Hundred—Splendid Prospects for a Good Year.

MORGANTOWN, W. Va., Sept. 14.—During the past three days students to the West Virginia University have been arriving here to prepare for regular work, which will begin on Monday.

It is always supposed that the institution opens on Wednesday, but no work is done until Monday following except the preliminary routine that is gone through with the officials. The outlook for the largest attendance in the history of the institution is very promising.

There are two hundred students now enrolled and Dr. Reynolds told your correspondent that he thought the attendance would reach the three hundred mark. Wheeling and Ohio county contributed Mr. and Mrs. Charles Morrison, who are in the law class, Charles H. Waddell, Howard S. Fox and S. S. Jacob, of West Liberty.

The law class is very full and will probably be as large as that of last year. Of the two hundred thus far enrolled sixteen are girls—an unusual number.

Since the last session the university grounds have been greatly improved in appearance. The buildings are now lighted by electricity from the university electric plant and eighteen arc lights have been put on the campus.

The students seem to have the true college spirit and in athletics especially will make a good showing. There is good material for a football team which will be organized in a few days.

All the professors are here now with the exception of Lieutenant Frank D'Witt Ramsay, who is in New Jersey. Dr. J. W. Hartigan is acting commandant in his absence.

There is much disappointment among the students that there is no college paper this year. The board of regents took the control of the Athenaeum from private hands and placed it at the disposition of the Parthenon and Columbian literary societies. As a consequence there will probably be no paper.
