JNO. L. McLAURIN TELLS OF MARKETING COTTON

Newberry, Nov. 7.-John L. Mc-Laurin of Bennettsville, former United States senator, spoke here Saturday in the court house on warehousing and marketing cotton. His audience was composed chiefly of farmers, though men of other professions were present to hear him. The attendance was not as large as it should have been, considering the importance of the subject and the able manner in which it was discussed. Senator Mc-Laurin spoke for an hour and kept his audience interested all the time.

A large portion of his address was about the proposed new warehouse bill which is to be presented to the next legislature, to take the place of the one passed by the last legislature and declared unconstitutional by the supreme court. He thinks the new bill will be all right in every particular, as it will avoid the features that were fatal to the previous bill.

The speaker stressed the idea that since cotton has become the cornerstone of international finance the south has it in its power to dominate largely the finances of the United States, through wisely directed efforts, instead of occupying a subservient position as it does today.

He said the time has not yet come when southern genius and statesmanship has proved equal to the task, but that some man may rise up and handle the cotton situation as Carnegie has handled steel or Morgan railroads. The speaker told how the cotton market was so controlled as to compel the cotton producer to turn loose, no matter what the price may be, and in this situation it is the small planter who suffers most, for the large planter is usually able to warehouse his cotton, even under present condition,s and hold it for a rise in the market.

The speaker magnified cotton, but said emphatically that no price can do the farmers much good unless they live at home and make their own sup-

The address was a good one and was well received and at its close the audience voted unanimous thanks to the speaker.
