SENATE ADOPTS PEACE RESOLUTION BY VOTE OF 43 TO 38 SATURDAY

Washington, May 15.- With few thrills and no hitch in the pre-arranged program, the Senate adopted today 43 to 38 the Republican resolution declaring the state of war with Germany and Austro-Hungary at an end.

The measure was in the form of a substitute for the peace resolution recently adopted by the House which dealt with Germany alone. The two proposals will be adjusted in conference beginning next week, the result to be endorsed by both Houses and the final resolution be sent to the President for signature.

That the President will veto it is a foregone conclusion, unchallenged by any speaker during the debate in the House or Senate.

It is uncertain when the final resolution will reach the White House but Republican leaders anticipate no difficulty in putting through a conference draft with little delay.

Vote As Predicted

The Senate vote today gave the majority of five predicted by Democratic leaders for the Knox substitute. The party alignment was about that anticipated. Three Democrats, Reed, of Missouri; Shields, of Tenn. and Walsh, of Mass. joined the Republicans in supporting the resolution. Two Republicans, McCumber, of North Dakota, who was paired, and Nelson, of Minnesota, lined up with Democratic opposition.

Prediction by leaders on both sides that the treaty of Versailles would remain in its present unratified position indefinitely were made during the debate. Senator Underwood, of Alabama, in his first speech in his new role as Democratic leader, declared the Republicans had apparently "foreclosed" action on the treaty for the present session of Congress. From the republican side, Senator Harding, Republican, Ohio, declared the resolution was a demonstration against the "one-man rule," of President Wilson.

The resolution was denounced as "futile, impotent, useless and done for no other than political purposes, to deceive the people," by Senator Hiram Bland, of Nebraska, administration spokesman. He also reiterated, against Republican denials, that President Wilson's pronouncements had "pledged" the nation to the league of nations.


