CONFEDERATE WIDOWS' HOME.—The second anniversary of this institution will be celebrated this morning, at the Home, in Broad street. Addresses will be made by Colonel B. H. Rutledge, M. P. O'Connor, Esq., Colonel Edward McCrady, Colonel T. Y. Simons, Esq., and others. The annual report will also be read, showing what has been accomplished by the lady directors of the Home.

BILL OF MORTALITY.—The report of the Health Officer, for the week ending November 6, shows that twenty-eight deaths have occurred in that period, eleven of which were colored. Of the whites eight were adults, four male and four female. Two male and one female infants. The colored deaths show four male and two female adults; five male and six female infants. None of the adults were over seventy.

T. J. STAR OF THE WANE.—At the meeting of Council last night T. J. Mackey was stripped of the last insignia of office. His resignation of the high sounding position of Inspector-General of Timber and Lumber, tendered on last Thursday night, was promptly accepted. A communication was read from lumber dealers asking that the office be abolished; and, lastly, one of his former subs was appointed, temporarily, to fill his place.

OLD TIME OUT OF JOINT.—The city monitor faltered yesterday from folks of the deceiving hours, but persistently kept its hands pointing at six. A variety of sounds, and strikes innumerable were heard Monday evening, and it is now stated that the spur-wheel is broken and further motion suspended. When the clock was repaired, it was warranted to keep time for a stated period. St. Michael's clock is a public nuisance and should receive careful attention.

TERRIBLE ACCIDENT IN AUGUSTA.—The Augusta Constitutionalist says: "On Sunday morning, about half-past six o'clock, a small colored boy, who serves his mother, a stewardess on one of the passenger trains of the South Carolina Railroad, sustained the loss of an arm in the following manner: As the corner of Washington and Reynolds streets he attempted to board the 830 passenger train, when he was struck, in passing by the gulchpost at the corner of the pavement, which broke his hold on the railing, causing him to fall with his left arm across the railroad track. The cars passed over his limb, crushing it in a horrible manner, and rendering it necessary to amputate his arm at the shoulder."

A DRUMMER TRICKS THE DETECTIVES.—Majority of the HABES CORPUS SUSTAINED.—Mr. Wm. T. Birdsell, a drummer from foreign parts, was arrested yesterday for violating the municipal laws relating to that class. He was taken to the august tribunal presided over by the Mayor, and required by that functionary to give bonds for his appearance the next day. By the advice of his lawyers, Messrs. Durea & Cohen, this was refused, and he sued out a writ of Habeas Corpus. This was heard at 12 o'clock before Magistrates Whiting and Minot, and Birdsell was set at liberty. This is the first instance in which that persecuted class, known as drummers, have brought the habeas corpus to bear upon their tormentors, and the success of the movement will doubtless induce other adventurers to brave the danger of a capture.

THE CITY BILLS.—Alderman Barrow was somewhat exercised last night because, in examining the Treasurer's books, he found \$52,000 in city bills represented as cash when the aforesaid bills were worthless. To his comprehensive mind the remedy for the error was simple. The bills do not cash and they represented nothing, having been recalled. They were a clog on the wheels of government, and he urged the appointment of a special committee who would make an audit of the entire \$52,000, and thus save the Treasurer the trouble of burdening his book with these figures. Other Aldermen were not so sanguine. They apprehended that the time might come when those bills could be made useful. A lively debate ensued, which resulted in the overthrow of Barrow's motion, and the retaining of the bills in the city strong boxes.

SPECIAL MEETING OF CITY COUNCIL.

The disagreeable weather prevented the Aldermen from coming promptly to time, and had the effect of reducing the number of spectators. At a quarter to 8 o'clock the meeting was called to order. Present the Mayor, Aldermen Geddings, Potter, Cunningham, Volt, Collins, Barrow and Greene, white; Holloway, Howard and Brown, colored.

The Mayor stated that the meeting was called for the purpose of taking up the unfinished business on hand, and of considering any motion that might come before Council.

Alderman Barrow offered a resolution that the resignation of T. J. Mackey, as Inspector-General of Timber and Lumber, offered to Council on the 4th instant, be accepted.

The question being put the resignation was declared accepted, only Alderman Volt and Greene voting no.

Alderman Geddings presented the petition of A. T. Stelling for a tavern license. Referred to the Committee on Licenses.

The petition of Rev. A. T. Porter for payment for repairs done to the gutters belonging to the steeple of the church, which was public property, was referred to the Committee on Public Buildings and Power to act.

The petition of Mrs. Mooney for payment of land taken to widen East Bay street was laid over, no money quorum being present.

A number of accounts presented by Alderman Geddings were laid over for the same reason.

Alderman Greene presented a favorable report on the petitions of Robert Turner and J. A. Trieste for tavern licenses; Mrs. O'orman and Mrs. C. Hardon, for junkshop licenses; Collins & Morse for license for theatrical performances during the season; Mr. Parker, of the Mills House, for liquor license; Alex. Joseph for junkshop license; John H. Teigen for a transfer of license from John A. Cook & Co. Accepted.

Alderman Greene, from the Special Committee of the Fire Department, asked further time. Granted.

The report of the City Sheriff, showing receipts of \$120 75 for the past month, was received as information.

The petition of Patrick Kenny to erect a woolen building. Referred to Committee on Brick and Wooden Buildings.

The petitions of Joseph Dayton and A. H. Abraham & Sons, for liquor licenses, were referred to the Committee on Licenses.

The petitions of Thomas Caragher and Hamilton Stawson, acting sergeants of upper station house, for increase of pay, was, on motion of Alderman Collins, laid on the table.

A petition was read from the lumber dealers, commission merchants and mill men, asking for the repeal of the existing act of Inspector-General of Timber and Lumber, and showing that the same was prejudicial to the business interests of Charleston.

On motion of Alderman Collins, the petition was referred to a special committee of three. The Mayor appointed Alderman Collins, Howard and Greene.

An account of Major Weston for material purchased, and for back pay as keeper of the artesian well, was referred to the Committee on Accounts.

The petition of M. Dehon, executor, for renewal of certificate of stock, was referred to the Committee of Ways and Means.

The Committee on Brick and Wooden Buildings reported that they had considered the petition of W. P. Russell for the erection of a wooden building, and found that the work had been commenced before the petition was presented.

On motion of Alderman Geddings, the petition was referred back to the committee, except that portion relating to steam engines, which was referred to that committee.

Alderman Collins offered a resolution that the Mayor be and he be appointed Mr. Christopher J. Jenkins to perform temporarily the duties of Inspector-General of Timber and Lumber. Carried.

Alderman Volt and Greene voting no. Alderman Geddings presented a resolution that, whereas many persons are defaulters and have failed to make their returns, and it was the wish of Council to avoid the disagreeable necessity of publishing their names, that the time of making returns to the City Appraiser be extended to the 15th of November. Carried.

The Mayor stated that the annual meeting of the Cheraw and Darlington Railroad would soon convene, and that he had appointed Mr. Edwin Bates to act as proxy for the city interest in that road. On motion, the appointment was confirmed.

Alderman Geddings stated that the city owned a large quantity of real estate in the municipal limits; many of the leases had expired, and he called for a prompt report from the Special Committee appointed on that subject.

Alderman Barrow offered a resolution that a committee be appointed to burn the city currency now in the vault of the treasury. He stated that there were \$300 of old and \$48,000 of new issue, a vote being taken, the motion failed.

On motion of Alderman Greene, Council adjourned.
