THE NEW YORK AND SOUTH CAROLINA STEAMSHIP COMPANY.—In our advertising columns will be found the announcement of the proposed sailing on the 13th instant, from New York, of the splendid new iron side-wheel steamship organized with the view of affording increased facilities for shipping, and the travelling public between Charleston and New York. In all respects these commodious and substantially constructed vessels serve Charleston a useful purpose at this time, in the freight facilities which their presence insures to our port; in the elegant cabin accommodations which they present to the travelling public; and above all, in the lesson taught by their model and build, which gives the immense carriage capacity of 2700 bales cotton on a draft of ten to eleven feet, forever disposing of the doubts and anxieties that have prevailed on the deep water question, and suggesting forcibly to all, the views we expressed some weeks since that it would be more economical to construct vessels adapted to the trade of existing ports than to attempt the founding of new seaports to suit old and ill-constructed ships. One is a practicable measure, available to us now; the other discounts the future, and will be costly and chimerical. The Tennessee and South Carolina are largely owned here, and in Georgia, and this public-spirited enterprise commends itself to the business communities of Charleston and the South-west, as worthy of liberal support. We sincerely trust that the new line, which offers so powerful a support to the business public, will prove remunerative as an investment to the owners. Messrs. Wagner, Huger & Co. and Messrs. Courtney & Trenholm will manage these freight vessels.

The United States vs. Dr. A. G. Mackey et al. On one of the counts for the defence, it was ordered that A. G. Mackey be allowed to sever his defence.

SPECIAL MEETING OF THE CITY COUNCIL.

Present—The Mayor; Aldermen Geddings, Cunningham, Collins, Barrow, Voigt, Holloway, Brown, E. P. Wall, L. F. Wall, Howard, Small.

The meeting was called to order at 8 o'clock, one hour after it was summoned, and it then needed several raps of the gavel to induce the Aldermen to leave the Mayor's chamber.

The Mayor stated that the meeting was called specially to consider the License bill.

The returns of the Harbor-master and City Sheriff from the 10th of December to the 1st of January, showing receipts respectively \$246 98 and \$297, 25, were read and forwarded to the Mayor.

The bill was then taken up by sections at its second reading.

The first section was read, when Alderman E. P. Wall moved to amend as follows: "Any person, persons or corporation taking a license, it shall be on the condition precedent that in the conduct or management of such business, pursuit, or calling, no distinction shall be made on account of race or color between visitors or persons applying for the privilege or benefits of the business or establishment. And any violation of this provision by the proprietor, or manager, or employee, shall forfeit the license. And it shall be the duty of the police promptly to report to the Mayor any violation coming to their knowledge, who shall declare the license forfeited, and impose such other penalties, in his opinion the nature of the case deserves, half of the fine to go to the Mayor, and the other half paid into the city treasury."

The yeas and nays were called for and resulted as follows: Yeas—Barrow, Brown, Holloway, L. F. Wall and E. P. Wall. Nays—Collins, Cunningham, Geddings, Howard, Small, Voigt and the Mayor.

The Mayor, in explaining his vote, said that he took the same view as had been expressed by the City Attorney—that the State had enacted a law whereby all parties could obtain redress; and though the amendment proposed met with his hearty support, it would, if passed, be imperative. The bill before them was one simply to raise supplies, and he would vote nay.

During the call Alderman Howard hesitated somewhat, but gave an emphatic no. Alderman Small also voted no promptly, and in reply to a remark made by E. P. Wall, who exclaimed "Et tu Brute," said he wanted to refer to the courts.

The first section was then passed—the two Walls voting yeas.

The second section was then taken up and passed.

Alderman E. P. Wall moved an indefinite postponement, which was lost.

The third section was also passed, Alderman E. P. Wall moving to lay the section on the table, but received no second.

Sections four, five and six were then passed with some amendments.

Alderman Voigt moved that section seven be considered separately as regards the different branches of business, which was carried.

Colonel Hayne was present, and he had the honor to preside at the action of Council on the proposed license, that he had been allowed the right to represent a certain class of the community, who felt aggrieved at the sweeping features of the bill relating to them. He disclaimed any attempt at objection, but said that it was an old axiom that there could be no taxation without representation, and the taxing citizen should have an opportunity to represent to the lawgivers wherein they felt that they had been unequally dealt with. The brokers as a class knew their grievances better than the framers of the bill, and he was present to represent them as succinctly as possible. He then reviewed the different points in the bill bearing on the brokers, and showed that the taxation on each branch of that business when imposed on one person was a burden too heavily to be borne. He suggested several changes, and read not materially reduce the revenue, but would guard against the distinction that the brokers had been dealt with.

Daring Mr. Hayne's remarks, Alderman Barrow left the chamber, but soon returned somewhat flushed, and interrupting the speaker, said that Council had met to frame a bill, and he moved that they do so or adjourn.

Alderman E. P. Wall said that Colonel Hayne had been granted full permission to address Council without limiting him to one subject, and they were in honor bound to hear him.

Alderman Barrow said that it was not requisite for the community to interfere in the business of Council. When the bill was raised and engrossed, it was then time for those who were aggrieved to present their complaints.

Alderman Small moved that Colonel Hayne be heard, and as no one seconded the motion, Alderman Barrow, at that point individual with a forced calmness, said that he almost sublimely, "forced calmness," placed his spectacles firmly on his nose, and propelled himself from the chamber in a loud judgment, and did not return until Colonel Hayne had concluded his remarks.

After a variety of motions, it was decided to resume the consideration of Section 7 by items, and the various branches of business were then taken up and considered separately. The bill, as amended, is as follows:

A BILL TO REGULATE LICENSES.

SECTION 1. Be it ordained by the Mayor and Aldermen of the City of Charleston in Council assembled, That every person, firm, company or corporation, who shall hereafter be engaged in any trade, business or profession hereinafter mentioned, shall obtain, on or before the 30th day of January, A. D. 1870, or within ten days thereafter, a license for the trade, business or profession, a license therefor, in the manner hereinafter provided.

Sec. 2. Every person, firm, company or corporation required by this ordinance to obtain a license to engage in any trade, business or profession, for which a license is required, shall register with the City Appraiser or Assistant City Appraiser (1) His or their name or style, and in case of a firm or company, the names of the several persons constituting the same;
