

Cable Despatches.

LIVERPOOL, November 24.—Noon.—Cotton opened quite active, at yesterday's advance, with a prospect of the day's sales amounting to fully 16,000 bales—middling uplands 14 1/2. Breadstuffs firm.

LONDON, November 24.—Noon.—Consols 90. Five-twenty 70 1/2.

LONDON, November 25.—The condition of the Mexican Empire is the leading topic in England and the continent.

Trieste papers say the state of Empress Carlotta's health is unchanged.

The Sunday Gazette, of this morning, says the Royal Commission on the neutrality laws will soon commence its sessions. Lord Cranworth will be President of the Commission, and among its number will be Lord Houghton, Sir R. Phillimore, Dr. Fryer and W. H. Gregory.

There are vague reports that the Government proposes to send twenty militia regiments to Ireland.

Paris, November 25.—It is rumored that the Imperial Commission appointed to consider the re-organization of the French army, will report in favor of adopting the Prussian military system.

Peston, November 25.—The Deak party have adopted an address to the Emperor of Austria, asking for a restoration of the laws of 1848, and promising that the Diet will assent to the wishes of the Emperor, as expressed in his recent proclamation.

Florence, November 25.—The aspect of affairs between the Italian and Papal Government is assuming a more conciliatory tone.

Trieste, November 25.—The Emperor Maximilian is expected at Miramir in December.

LONDON, November 25.—The money market showed more firmness at the close of business yesterday.

LIVERPOOL, November 25.—The cotton and breadstuffs markets closed firmer on Saturday.

LONDON, November 26.—Further arrests of suspected Fenians have been made in Ireland. The National troops are ready to move at a moment's warning. Proposals for some parts of the Nicaragua Route have been awarded. The Times considers that the entire scheme will be distributed between the governments of England, France and the United States.

There has been renewed fighting in Candia. It is said that the Turks were badly beaten and suffered greatly—no less than 3,000 having been killed and 2,000 taken prisoner.

LIVERPOOL, November 26.—The cotton market opens quiet and steady. Middling uplands quoted at 14 1/2. Sales to-day will probably reach 10,000 bales.

LONDON, November 26.—Consols 90 for money; Five-twenty 73 1/2.

News Items.

MOBILE, November 25.—A fire this morning burned two squares, between Lawrence and Warren streets, on St. Francis, comprising thirty to forty buildings. Probable loss \$100,000; partially insured.

New York, November 25.—Gen. Butler delivered a lecture at the Academy of Music, Brooklyn, last evening, which was attentively listened to. On the subject of the re-organization of the South, he said that neither political expedients, conventions, the President, nor Congress, could compass it. All the devices of State and craft must fail. Even universal freedom cannot accomplish it, and universal impartiality is the only safe and the only danger.

The only safety is in universal education, intellectual and religious. The common school and church are the only bases upon which the South can be safely and permanently reconstructed. Butler argued that there is power in Congress to establish schools in the South under the clause of the Constitution which says that Congress shall have power to provide for the common defence and general welfare of the United States. On the subject of the impeachment of the President, he claimed that an improper public speech of a high official is impeachable, that the Senate, from its members from eleven States, are excluded and some of them expelled, is the legal and highest court of impeachment; that if the accused neglects or refuses to appear before the Senate when summoned, he may be tried, convicted and deposed from office in his absence; that all powers of impeachment are derived from English law; and that, according to all law and precedent, the President, if impeached, must be prevented from exercising the functions of his office. Butler enumerated the charges he had to make against the President as impeachable, the Senate, viz: 1st. Drunkenness in office. 2d. The making of indecent and inflammatory harangues. 3d. Tyrannically and unconstitutionally, as chief Executive officer, usurping the lawful rights and powers of Congress in appointing Provisional Governors for the South, the re-organization of the State Governments and the assumption of power to dictate who should vote in the reconstructed States. 4th. The corrupt use of the appointing power. 5th. Improperly using the constitutional power of pardons for offences against the United States. 6th. Appointing rebels to office. 7th. Refusing to execute the constitutional laws of Congress in insurrectionary States. 8th. Conspiring with John T. Monroe to prevent and disperse a lawful convention of loyal citizens in New Orleans, and inciting Monroe and his associates to disperse said convention and kill the members thereof. The address was very long and undisturbed.

A suit has been commenced before the Supreme Court, by John H. Lester, against Gen. Butler, charging him with false imprisonment—damages laid at \$100,000; also, with a fraudulent conversion of property—damages \$40,000. Lester received a free pass from Secretary Stanton, during the war, to bring his family North. Gen. Butler disregarded the permit and imprisoned him. Notices of the writs were served yesterday.

At a banquet given to Gen. Nelson Taylor, he stated in his speech that he should not content at the seat of John Morrissey in Congress.

Fifteen steamships sailed from this port yesterday, including seven from Europe. The freight of these fifteen steamers is valued at over \$7,000,000.

Col. Kelly is now in charge of Fenian affairs here. Stephens evidently having left for Ireland. Special messengers have recently arrived from Ireland, who state that Ireland will soon be in a state of complete insurrection. Large quantities of Springfield, Enfield and Spencer rifles are hourly arriving here, which are being constantly shipped to Ireland. All the arms intended for service in Canada have been turned over to Stephens.

The Tammany City Convention have nominated Richard B. Connelly for Comptroller.

The shipments of specie for the week amount to \$782,000, and the total imports of the week were nearly \$4,000,000.

It is stated that a large number of men have been duped by a concern here, advertising free passage, a homestead and religious liberty in Brazil.

A Paris correspondent, of a late date, states that the alliance between Prussia and Russia, and the counter alliance between France and Austria are consummated.

The *Moniteur* says the war budget and the army are to be increased, as preparation for eventualities are likely to occur.

WASHINGTON, November 25.—Official despatches which have reached Minister Romero from Mexico, state that Col. Rafael J. Garcia has been appointed Military Governor of Puebla, and has established his Government at the city of Teapooxtla and issued a proclamation to the people of the State, calling on them to take up arms against the invaders. Gov. Garcia reports that the French have lost the whole of Puebla, keeping only the line of the main road from Vera Cruz to the city of Mexico.

Many of the Washington correspondents are speculating as to what will be the contents of the President's forth-coming annual message, and some of them broadly assert that he will make terms with Congress on the restoration policy, in view of the result of the recent State elections. This, too, is mere speculation, and it were, therefore, better to wait for positive information from the message itself.

Nothing definite has yet been received by the Government in relation to the claims on Great Britain for damages to commerce caused by the Alabama and other Confederate privateers. The correspondence between the two Governments is still in progress. It is a fact, however, that the present British Ministry is more disposed than the former one to give due and fair consideration to the entire subject.

A committee has been despatched North by the leading radicals here, to collect money to defray the expenses attending the formal exercises of welcoming back the radical members of Congress, and giving them a banquet next Saturday.

New York, November 26.—Havana letter, of the 20th, reports that the Saguehanna, with Sherman and Campbell on board, would leave for Mexico on the 23d.

The quarantine of vessels from New Orleans has been removed.

WASHINGTON, November 25.—The mission of Gen. Sherman is simply to view the military situation of affairs in Mexico, and add his assurances that our Government will sustain the constitutional party. It is confidently believed such representations will be sufficient to check all revolutionary plots and secure stability to the Juarez Government.

Owing to the pressure of business in the preparation of his annual message, no definite action has been taken by President Johnson upon the application of the Mississippi Legislature for the release or parole of Jefferson Davis. Commissioners Hillyer and Lowry are still awaiting a final decision.

Minister Romero had no part in the arrest of Ortega at New Orleans. A request for Ortega's release, by the Mexican Consul at New Orleans, was not acceded to by our Government.

The forth-coming report of the Pension Commissioner shows that \$13,000,000 were paid last year for pensions, and \$27,500,000 during the past four years; estimated next year, \$33,000,000. 54,000 names are on the army pension roll.

Smuggling still prevails on the Northern frontier and on the Rio Grande. 225 patents were issued for the week ending in the 24th inst.

\$93,000,000 in gold were in the Treasury on Friday night.

The President was engaged on his message yesterday, and declined all calls. None but foreign Ministers were received at the State Department yesterday, nearly all of whom are engaged there.

BALTIMORE, November 26.—It has been determined by Gov. Swann, his friends assert, not to convene a special session of the Maryland Legislature. It will meet on its regular day—10th of January.

BALTIMORE, November 25.—The steamship *Kearsy*, belonging to Mordecai & Co., of Baltimore, and running between this city and Charleston, founded at sea about sixty miles South of Hatteras, during the recent severe gale. The officers, crew and three passengers took to the boats, and all, except four colored seamen, were shortly after rescued by the crew of the United States steamer *Susquehanna*. They went to Havana, and were brought here yesterday, by the steamer *Liberty*, from Havana.

Some weeks since, in a case before the Circuit Court of Anne Arundel County, Judge Magruder refused to allow the evidence of a colored woman to be received, stating that, according to the laws of Maryland, no negro could testify in any case where one of the parties to the suit was a white person. He also declared that the civil rights bill was unconstitutional. On Saturday, he was taken before United States Commissioner Brooks, on the charge of violating the provisions of the Act. He declined an examination, and gave a bond to await the action of the United States grand jury, in December. It is intended to make this case a test question as to the constitutionality of the civil rights bill, and the case taken to the Supreme Court.

New York, November 26.—The anniversary of the evacuation of New York was celebrated to-day.

One of the largest provision houses in New York failed to-day. Liabilities stated at over half a million dollars.
