**WASHINGTON, May 24.** - Secretary Hay received from President Schurman of the Philippine commission a long message giving the results of meetings held with the native Filipino commission, sent by Aguinaldo to treat with the Americans. The message was laid before the president. He was very much gratified at its contents, which were said to be very encouraging for the outlook that something definite may be accomplished. President Schurman reported that the native commissioners will take back to their people the proposition for a form of government, etc., suggested by the American commission.

**It was stated on the authority of a gentleman who spent some time with the president that contrary reports from Manila that there were no differences of any consequence between the military and civilian members of the commission.**

**MANILA, May 24.** - The Filipino commissioners spent part of Tuesday at the residence of the American commissioners. They discussed every point of the scheme of government and the peace proclamation details, asking for information as to what personal rights would be guaranteed them. Colonel Charles Dwyer of the American commission explained that they would be the same as under the United States constitution. The Filipinos also desired information as to the school system to be established, and approved of the American policy of the separation of church and state. They also objected to the scheme on the ground that it gave them personal liberty, which they know they would have, but did not give them political liberty.

**Finally, the Filipinos said they were personally pleased with the plan, but could not endorse it officially. During the day the Filipino commissioners called upon Major General Otis.**

**There was much comment here on the coming of the Filipinos being enjoying. They were dressed in blue coats, scarlet trousers and gold lace and drive about the city reveling in the attention bestowed upon them, which was evidently exceedingly gratifying to them. They were the centers of continual levees at Filipino houses, where they had been entertained and had every opportunity to advance the interests of the insurgents. Military sentiment disapproved of the Filipinos being lionized by the civilian element. General Otis, from Manila, expressed his regret over the Filipinos' fondness for discussion, maintained the attitude he assumed with the first commission. He had no offer to make the Filipinos save that they should remain in the Philippines until they returned to the Philippine islands and it would be cheaper in the long run to whip the insurgents so thoroughly that they would never again be permitted to surrender rather than to parley with them and make terms which they might construe as a compromise. The army was also of the opinion that while the first commission was not more men and money in the beginning than the latter it will prove an effectual damper upon future insurrection, whereas, if the war is ended by a treaty without the aid of professional revolutionists among the Tagals may be encouraged to try again in a few years.**
