Will Be Built by North End Club.

Officers Elected For Year of 1901--Akron Fanciers Will Contest For Prizes--Local Sporting News.

The North End Athletic club will erect the finest home for an organization of that kind in the city.

At the annual meeting of the club Sunday it was decided to go ahead with the project as soon as plans could be prepared and the preliminary steps taken.

The matter was placed in the hands of the Directors who will have absolute control in the matter. They will select the site and purchase the lot. They will report at a special meeting to be held Jan. 4.

It is now proposed to purchase a lot on N. Howard st., north of the one on which the old hominy mill stands. It is near the corner of Howard and North sts. Another lot that is being considered is at the corner of Howard and Cuyahoga streets.

The new building will be at least 40x100 feet. It is the idea to make it large enough to accommodate any crowd that will gather to see the contest which the organization may give. Throughout it will be fitted up in first class style with all the latest appliances and devices for athletic exercise. Bowling alleys and baths will be features.

"When it comes to answering challenges from men who want to box, you can just count me out of it. There is no use of worrying or losing time over these 'challenges' or the sarcastic 'dings' in the papers. I shall pay no attention to them. Let all the would-be champions get out and fight if they want to. I am not one of the push. They may be all good fellows for all I know.

"As a middleweight I have beaten the world. As a middleweight I have held my own with the heavyweights. I do not say this to throw bouquets at myself, but as a plain statement of facts. Let the world consider them as it may.
