NEW COURSE IN DAIRYING
Owing to the great demand for young men to supervise the work in the Advanced Registry and Cow Testing Associations, the College of Agriculture will give a four-weeks course, beginning January 4th and ending January 30th. This course will prepare men for the Civil Service examination, which will be given the latter part of January. All persons are required to pass this examination before qualifying as supervisors. Most of the Advanced Registry work comes in the winter months, when the boys on the farm can easily get away and the testing pays \$2.00 a day and expenses. However, for one who is interested in dairying, the financial end of it is a small part, as compared with the experience and training one gets in visiting the best dairy herds in the state.



AN ORDINANCE.
An ordinance for the issuing and sale of Bonds for the raising of funds wherewith to pay for the extension of Water mains upon Union Street from North Court Street to Huntington Street and from thence south upon Huntington Street to North Street; Mill Street from South Court Street to Elmwood Street. Broadway Street from Grant Street to South Street.
Be it ordained by the Council of the Village of Medina, Ohio, three-fourths of the members elected thereto concurring.
Section 1. That it is deemed necessary by the council of said village of Medina, Ohio to issue and sell bonds of said village for the purpose of paying for the extension of water mains upon Union Street, from North Court Street to Huntington Street and from thence south upon Huntington Street to North Street from South Court Street to Elmwood Street. Broadway Street from Grant Street to South Street, in the amount of \$4,500.00 Twenty-five hundred Dollars.
Section 2. That the bonds of said village be issued in the sum of \$2500.00 for the purpose aforesaid, and that bonds shall be five in number and issued for the sum of \$500.00 each, and numbered consecutively from one, to Five and made payable as follows: one bond for \$500.00 payable on the 15 day of Sept. 1916, one bond for \$500.00 payable on the 15 day of Sept. 1917, one bond for \$500.00 payable on the 15 day of Sept. 1918, One bond for \$500.00 payable on the 15 day of Sept. 1919, one bond for \$500.00 payable on the 15 day of Sept. 1920, that said bonds shall bear interest at the rate of six per cent per annum payable semi-annually. Said bonds shall be dated Sept. 15, 1914.
Section 3. That said bonds shall express upon their face the purpose for which they are issued in pursuance of this ordinance. They shall be prepared, issued and delivered under the direction of the finance committee of said Council, and the Village Clerk, and shall be signed by the Mayor of the village, and sealed with the corporate seal of said village. Said bonds shall be registered in the office of the trustees of the sinking fund of said village in the name of the purchaser and shall bear interest as aforesaid.
Section 4. Said bonds shall be offered at par and accrued interest to the trustees of the sinking fund in their official capacity, and if refused by said officers, then those not taken by them shall be offered to the officers of the school board of said village, and those not taken shall then be advertised for public sale and sold in the manner provided by law, but for not less than par value and the accrued interest.
Section 5. The proceeds of the sale of said bonds, except the premiums and accrued interest thereon, shall be placed in the village treasury, to the credit of the sinking fund and shall be disbursed upon proper vouchers for the purpose of extending and laying water mains upon Union and Huntington Streets and Mill and Broadway Streets, as stated in the preamble of this ordinance, and for no other purpose, and the premium and accrued interest received from the sale thereof as aforesaid, shall be transferred to

the trustees of the sinking fund to be applied by them in the manner provided by law.
Section 6. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
