THE ROCK ISLAND MORTGAGE.

The Facts Relative to the Recent Foreclosure Suit Instituted in the United States Circuit Court.

TOPEKA, Kas., Oct. 28.—[Special correspondence]—On the 11th day of October a meeting was held in Topeka, composed of the county attorneys of the various counties through which the Chicago, Kansas & Nebraska (Rock Island) railroad runs, for the purpose of discussing the recent foreclosure proceedings instituted in the United States circuit court against said railroad company. This meeting was called by R. W. Griggs, county attorney of Meade county, and in his call to other county attorneys set forth, among other things, that "the counties through which the said road passes in Kansas, have in round numbers over \$2,000,000 invested in the stock of said road. This will all be swept away if we do not make common cause to thwart the all-too-evident purpose of the trustee, in conclusive co-operation with the Chicago, Kansas & Nebraska and the Chicago, Rock Island & Pacific railways." That your readers might have the truth, in view of the fact that the C. K. & N. and C. R. I. & P. railroads have been charged with an attempt to defraud the people living along the line of the C. K. & N. out of \$2,000,000, your correspondent felt called upon to furnish your readers with the facts in the case.

I find that on the 4th day of July, 1884, the Chicago Rock Island & Pacific Railway company executed a first mortgage on all its property, called an extension and collateral mortgage. In this mortgage it was provided that all bonds executed under its provisions should be secured either by a direct lien of this mortgage, as a first mortgage of one or more railroads and appurtenant property owned by said railroad company, or by a deposit of collateral bonds, secured by a first mortgage of one or more railroads and railway property, which by lease or traffic arrangement, shall have been made at the time a part of the railway system of the Rock Island company for the transportation of through traffic. The money with which the Chicago, Kansas & Nebraska railway was built was provided by the Rock Island company from a sale of its bonds issued under this mortgage, and secured by the bonds of the Chicago, Kansas & Nebraska Railway company as collateral. The Rock Island mortgage further provides that if the obligors in any of such collateral bonds shall fail to make payment of either principal or interest thereof, it shall be the duty of the trustee to cause proceedings to be instituted to foreclose the mortgage by which such collateral bonds shall be secured. The Chicago, Kansas & Nebraska railway is operated by the Chicago, Rock Island & Pacific Railway company under a lease which requires the Rock Island company to pay thirty per cent. of the gross earnings of the railway of the Chicago, Kansas & Nebraska Railway company. As a matter of fact the net earnings of the Chicago, Kansas & Nebraska railway do not amount to thirty per cent. of the gross earnings by a very large sum. The Rock Island company is, therefore, compelled to pay not only the difference between thirty per cent. of the gross earnings of the Chicago, Kansas & Nebraska bonds, but, also, to make up

from its own treasury the difference between the net earnings of the Chicago, Kansas & Nebraska railway and thirty per cent. of the gross earnings. The Rock Island company has paid promptly the interest on its bonds secured by the Chicago, Kansas & Nebraska collateral bonds, but the earnings of the Chicago, Kansas & Nebraska railway have not been sufficient to pay the interest on its bonds, the deficit on the first day of January, 1889, being \$431,507, with a further deficit of \$600,000 on the first day of July, 1889, making a total of \$1,031,507. On this state of facts, under the Rock Island mortgage of 1884, it became the duty of the trustee in that mortgage, namely, the United States Trust company of the city of New York, to require the Metropolitan Trust company, the trustee in the mortgage executed by the Chicago, Kansas & Nebraska railway company, to institute proceedings to foreclose the Chicago, Kansas & Nebraska mortgage. This foreclosure proceeding, therefore, was instituted not because of any neglect on the part of the Rock Island company to pay interest on its bonds, but because the earnings of the Chicago, Kansas & Nebraska Railway company are insufficient to pay the interest on its bonds. The proceeding was instituted, not by the Rock Island company, but by the trustees for the creditors of the Rock Island company.

Since the commencement of the construction of the Chicago, Kansas & Nebraska railway, the stock of the Chicago, Kansas & Nebraska Railway company has depreciated in value over \$12,000,000, and its bonds have also depreciated. The taxes on the Chicago, Kansas & Nebraska railway in Kansas largely exceed the interest paid on municipal bonds issued in aid of its construction. And notwithstanding the fact that the past two years has been a crucial period in the history of western railroads the C. K. & N. has pursued a liberal policy toward the people of Kansas and has always responded when called upon for assistance for the destitute settlers on our western border.

The Rock Island and Santa Fe, two systems of railroad which have added millions to the value of property in Kansas by leading the march of immigration and progress into and through her broad prairies, have suffered materially from the financial depression, but with favorable crops during the next three years, will be able to regain the thousands lost in shrinkage of stock and lack of business.
