THE DODGE CITY GAS AND MINING COMPANY.

Last Wednesday evening there was a meeting of the citizens of Dodge City, at the real estate office of Finlay & Milton.

After considerable discussion, the meeting was called to order with G. W. Hoover in the chair, and W. F. Pettilon as secretary.

J. H. Finlay moved that the company should be called the Dodge City Natural Gas and Mining Company.

It was then moved by B. F. Milton, that the capital stock of this company be one thousand shares of \$10.00 each.

On motion of C. A. Milton, the number of directors was limited to nine.

A. Gluck moved that the chair appoint a committee of five stockholders to select nine members of the company as a board of directors.

The following gentlemen were appointed as a committee: H. Juneau, J. Collar, J. H. Crawford, James Langton and J. H. Finlay.

The committee then made their report of the following named members they had chosen: J. H. Finlay, W. C. Shinn, N. Healy, A. Gluck, J. S. M. White, Ed. Weibenson, W. F. Pettilon, James Langton and J. Collar.

On motion of B. F. Milton, the report of the committee was adopted.

The capital stock of this company is \$10,000, of which sum \$2,000 was raised at the meeting.

Since that time a large part of the stock has been subscribed, and more enthusiasm prevails over this scheme than has been manifested for a long time, among the leading business men.
