the city of Albuquerque any other time from which to make selections. "Answering paragraph two, he specifically denies each and every allegation in said paragraph contained. And for further answer he states that the fire committee was never able to see the best letter men that those employed because of the fact that there were no other applications. "Answering paragraph three, the respondent denies each and every allegation in the said paragraph. And for further answer he states that the preliminary instructions are always given and can be given inside quarters, such as now, and where to ride on apparatus, how to lay leading hose from hydrant, further than that you cannot do since all fires must and are fought directly. The leading hose, however, is always laid in the same manner. I have maintained a regular schedule of practical instructions on the corner of Second and Chapin nearly every Sunday morning until the end of the first quarter, when the two motor engines were in service. At this time the mayor reprimanded the respondent severely about the excessive amount of gasoline consumed during that quarter. From this time I discontinued that practice and followed only such practical usages as were required by the drivers. In the face of this I have never refused to instruct on the contrary I was prohibited. The instantaneous response of alarms of fires the method employed in fighting the fires, all of this clearly shows that there never was any unnecessary delay. As far as the efficiency of the department is concerned our fire loss has been nil, so to speak. "Answering paragraph four, respondent denies each and every allegation in said paragraph contained. And for further answer he states that he was compelled always to select from the applications. "Answering sub-section (A) of paragraph five he denies each and every allegation that the said paragraph contains. And for further answer he states that he never knew of any excessive drinking of any member of the fire department since he has been chief. "Answering sub-section (B) of paragraph five he states that the mayor reprimanded him when afterwards the instances have ever come to notice of this respondent, the first when Capt. Fred Russell took a flask of whiskey from Cal Thompson and gave it to this respondent. Thompson, however, claimed that he had the whiskey for medicinal purposes and since the flask was still sealed, and a very small one, respondent took no further notice of the matter. The second instance was when Thompson one morning reported to respondent that he had seen one of the firemen take a drink of whiskey from a flask, at the station; he, however failed to give the name of the fireman. I did not give an answer to the report but when afterwards the boys were all downstairs, respondent opened each and every locker (having a duplicate key to each locker) and looked over everything very carefully but found no trace of whiskey anywhere. There are the only two cases that ever came to my notice. Dr. Rice ordered a quart of whiskey the first thing when called upon to look after the frozen hands and ears of the firemen, three cents ago. Since then respondent took with under lock and key at the station a quart of whiskey for the same purpose that Dr. Rice had used it for. No one else has access to it, and respondent had access to it.

on the firemen each a drink on a very few occasions, not more than three in two years, when they were out all night at fires, and came to the quarters wet and cold. After the change of hose and after they had changed their clothes washed and cleaned up, I would give them a drink as I have explained above. If I had been asked the proper question at the committee I would have explained at that time I was only asked if I had ever seen whiskey drunk at the station. "Answering sub-section (C) of paragraph five this respondent denies each and every allegation in said paragraph set forth and further answering this respondent states that there has been but one case of unbecoming conduct of any member of the fire department called to his notice, since the present mayor became head of the city government. That was an occasion where two firemen got in a scrap and immediately they were taken to task by the chief. It was impossible to discharge and fill their places and the fire committee, as well as the chief, knew this to be a fact. It was impossible to get along with two vacancies and after severe reprimand they were permitted to continue in the service. That respondent grieved over this affair more than any other that has ever happened during his administration but there was no way to fill their vacancies if he had dismissed the two men and much against his will he had to continue them. "Answering paragraph six, respondent states that this is fully answered in paragraph one of the answer, it being one of the original charges set forth on respondent on December 6, 1915, but respondent denies each and every allegation in said paragraph contained. "Answering paragraph seven of sub-sections A, B and C of the said paragraph, respondent specifically denies each and every allegation in said paragraph contained and calls for strict proof thereof and further answers that he never knew of any excessive drinking of any member of the fire department since he has been chief. "Answering paragraph eight, this respondent denies each and every allegation in said paragraph contained. "Further answering the several charges made against this respondent of incompetence and inefficiency, he states that his whole record is open for inspection, that he has successfully put out your fires and confined them to their places of origin, that he has faithfully labored throughout his entire career to lift up the department from the crucial form possible to one of a high standard of efficiency, there having been specific rules laid down for fighting fires, by men who have spent a lifetime in the study of this matter, such as the national board of fire engineers, the national board of fire underwriters and these rules are universally followed throughout the world, and respondent has tried to conduct the management of the Albuquerque fire department along these lines. In the motor engine appeared on the field, unknown conditions had to be faced and dealt with, one of the most important of these was the speed of the motor-fire truck. There seems to be an unwritten law about that as there are communities, and keeping step with the general sentiment of the entire country, respondent has long since dealt with the matter by placing orders at each station, giving speeds he thought were safe. Accordingly, the maximum speed of the new motor truck was set down to fifty miles per hour instead of seventy, at which speed the said machine is geared. If there are any difficulties shown

in your fire department (if there is any) it is solely due to the fact that never in the history of this fire department were we able to hold the men on the job, and so long as those conditions prevail efficiency in the highest sense can never be hoped for. This is a question that should resolve the full thought of the council, since it is beyond the scope of the respondent, or any other man, that may hold the position as fire chief, of this town. "Therefore, respondent asks that the charges filed against him be dismissed. "Lowering Insurance Rates." The following letter from W. A. Moore, district inspector of the Rocky Mountain Fire Underwriters association, bearing upon the case, was read by the city clerk: "Unless vitally concerned it is neither the intent nor purpose of the underwriters to take part in or be drawn into any controversy or misunderstanding which might arise between the head of any city administration and (or) any head of municipal department. "Our attention has been directed, however, through the daily papers to certain statements appearing in the list of charges which the present mayor of Albuquerque has preferred against John Klein, chief of the Albuquerque fire department, and we therefore feel it incumbent upon this office to refute these statements, inasmuch as the information contained therein has no authorization from this office. "We therefore consider an injustice to have been done the underwriters, and in this connection beg to state most emphatically that we have no criticism to offer on Mr. Klein's services as fire chief. "It is in view of the fact that an efficient fire department is one of the most important factors upon which fire insurance estimates are graded and based that we refer to the efficiency of Chief Klein. "Furthermore, we feel that it is absolutely necessary to set right in the minds of all property owners of the city of Albuquerque the exact situation with respect to the fire insurance rates, and to correct the impression which has been created through statements appearing in Article VII of the aforesaid charges. "Contrary to the assertion that insurance rates have been raised in the business district of the city of Albuquerque, we respectfully direct your attention to the fact that they are constantly being lowered through improvements in building construction, changes in occupancy, and the elimination of various fire hazards. On the other hand, there are individual buildings on which the insurance rates have been raised, and which may be caused by an increase in fire hazard due to a change in occupancy, increase in exposing buildings, openings made in fire walls, handling of gasoline, etc. These buildings, however, may be restored to their former rating, or may secure even lower estimates, upon the elimination of these increased hazards and by further improvements. "We trust that you will give this communication your most favorable consideration. "Respectfully submitted, "W. A. MOORE, "District Inspector." "Burrows' Report Tabled." While the hearing was passed up until a bit of the council's time. The report made by Chief A. C. Burrows for December was tabled, on the motion of Alderman Fred Russell, until the investigation. Mr. Hammond wanted to know why. Mr. Grunfield's reply was that there was no fire chief. Mr. Hammond

voted negatively, six councilmen voting to table the report. Dr. R. L. Hunt was absent at the time. Alderman George C. Seiber, referring to statements in newspapers that he had not signed the fire department payroll as chairman of the finance committee, stated his grounds to the council. He said it was because the roll contained the name of Chief Burrows in whose appointment the council had not concurred. "Substitute Is Lost." Mr. Skinner moved that Mr. Scherer be sustained. Mr. Gilbert seconded him. Mr. Hammond then stated that he had signed the roll as chairman of the fire committee after inquiring the word "acting" before Chief Burrows' title. He said he had had advice that his was proper action. Mr. Skinner said that the previous city clerk had not made out checks until he signed them as acting head of the finance committee. The city attorney was asked for an opinion. Mr. Wikerson said that the signature of the chairman of the finance committee was not necessary upon the payroll. Mr. Hammond then offered a substitute for Mr. Skinner's motion. This was lost for want of a second. City Clerk Hubbes arose under special privilege and said that the clerk did nothing more than check that the mayor had signed the checks under the city's system of paying. Mayor Assumes Responsibility. "The mayor will shoulder the blame," declared Mr. Boardman. "I am perfectly willing to stand the blame. I believe I performed my duty. I think Mr. Burrows was entitled to the salary." "When the question was called, Mr. Scherer asked to be excused from voting on the matter concerned him. Permission was granted. Skinner, Gibson, Gilbert, Coen and Grunfield voted "aye." Hammond opposing. Mr. Grunfield then introduced a motion instructing the city clerk to draw up an ordinance to be presented at the next meeting, instructing the mayor and city clerk not to sign warrants of any kind without the approval of the chairman of the finance committee. On the eve of the reconvening of congress after the holidays, uneasiness prevails among senators and representatives by reason of the acute situation that exists between this country and some of the European belligerents. President Wilson has cut short his honeymoon trip in Virginia in order to be in the capital when the legislators begin to place resolutions before their respective houses with regard to the alleged infringements of American rights by belligerents. Close inquiries are to be made into the sinking of the British steamer Persia with the loss of at least one American life, before action is taken in this matter by the American government which is represented by Washington dispatches as being determined to take any step warranted by the facts elicited. The Austrian charge d'affaires at Washington has asked the Washington authorities to withhold their Vienna reports that the Russians are on the offensive at various places, but that all their attacks have been repulsed. Artillery engagements and mining and sapping operations continue on the French, Austria-Hungary and Dardanelles fronts. In the Balkans, capture in Montenegro, where the Austrians claim to have put to rout a Montenegrin detachment which attempted an advance on the Tara river, there is no change in the situation.
