IT IS CLOSED AGAIN

Flames Still Holding Control in the Levels of the Anaconda.

Under the Orders of the Superintendent the Bulkheads are Put in Place Again—Futile Efforts to Remove Bodies From the Depths of the Mine.

BUTTE, Dec. 9.—It was nearly midnight on Saturday when Superintendent Carroll determined to put back the bulkheads that had been removed from the Anaconda mine early in the day.

It was found impossible Saturday night to work the 600 foot level of the St. Lawrence, which runs into the 600 foot level of the Anaconda. The fire was still smoldering and the opening of the bulkheads evidently furnished draft which threatened to rekindle the flames.

While the temporary obstructions were removed from the shaft, extensions were made to the pipe conveying steam into the mines and they have been put into full operation.

It is believed that this will aid materially in putting an end to the fire which, while pretty well spread, is not so extensive as to alarm those in charge of the property.

It is believed that, by the constant use of the steam service, the fire can be held in check and confined to its present limits. There is no telling how long the mine may remain closed, although Superintendent Carroll is hoping to open it in time to resume operations at a date that will keep the works at Anaconda in motion.

Mrs. Bowman Makes an Uproar. About 11 o'clock Sunday night Oliver Bachmann was attracted by a great uproar proceeding from Oak street near Front.

Mr. Bowman was told that a woman was being murdered, and on hurrying to the scene found Nellie Bowman in a violent altercation with the man who passes as her husband.

Chief O'Brien of the Butte fire department and Chief Thomas of the fire brigade in that city visited Anaconda yesterday. In company with Agent Whitaker, of the Gaylor alarm system, these gentlemen visited the smelter works and took a general view of the system, in use for the works and the city.

No tests were made, although Chief Thomas offered to cut into the pipes, so that no excitement might be occasioned, and demonstrate the promptness and efficiency of the service by any calls that might be suggested.

A Superb Performance of Shakespeare's Great Masterpiece.

The six nights of Shakespeare were begun at Evans' opera house last evening, with a superb production of "Hamlet."

TOPICS IN MISSOULA

First Train Through to Frenchtown on the Cour d'Alone Branch.

Prominent Men of Missoula Among the Excursionists—Real Estate Transfers—Other Notes.

Special Correspondence of the Standard. MISSOULA, Dec. 9.—The first train on the Cour d'Alone branch of the Northern Pacific left here at 2 o'clock on Sunday afternoon for Frenchtown. The distance is 16 miles and the track thus far has just been completed by Woods & Larson, contractors.

The round trip was made in two hours, which is considered good time for a new track. About 2,000 of Missoula's business men were aboard, and the inhabitants of Frenchtown will long remember them as jolly fellows.

Frank Higgins and G. A. Bennett. The train crew consisted of E. Dunn, conductor; J. E. Banerman, engineer; and Tom Wong, cook.
