THE MEMORIAL OF BUTTE CALLED IT DESECRATION

Wouldn't Announce or Attend the Fourth of July Mass Meeting at the Auditorium—Their Action Sharply Criticized. Saloon Keepers Roasted—A Rousing Meeting.

There was a hot old Fourth of July meeting at the Auditorium yesterday afternoon. There was an incessant popping of fire crackers with an occasional bomb of a giant cracker and the whizz of a rocket. If the Fourth of July celebration is only half as warm as that meeting it will be hot enough to suit everybody.

At the opening of the meeting A. F. Bray expressed his satisfaction at the large number of people present and regretted that the clergy of the city had not seen fit to attend and to read notices of the meeting from their pulpits. He said that in accordance with the instruction of the last meeting he sent the following to each clergyman of the city:

"Reverend Sir: You are respectfully requested by the executive committee of the Fourth of July celebration to invite the members of your congregation to attend a mass meeting to be held at the Auditorium at 2 p. m. Sunday, June 19, at which time the preliminary arrangements for the demonstration will be made.

"The short time at our disposal makes it necessary to hold the meeting on Sunday afternoon, and in view of the victories that have been achieved and the cause of the present war for humanity's sake and the triumph of right that are to be celebrated, we do not believe that you will consider the gathering a sacrilegious one."

Mr. Bray said that he also sent this notice to the clergymen: "Reverend Sir: As there are so many of our fellow citizens who have given up their all for their country's honor and the cause of humanity, it is earnestly requested that you attend the meeting on Sunday afternoon, that by your presence and voice you may assist in celebrating the glorious victories which have been achieved.

Mr. Bray said in his reply he received the following: "A. F. Bray, Chairman—Dear Sir: Your communication containing an invitation to each of us to attend a mass meeting at the Auditorium, Sunday, June 19, at 2 p. m., in the interest of the Fourth of July celebration in our city, and a request to make known such meeting to our respective congregations on Sunday morning next, has been received. In reply we respectfully state that we entirely disapprove of such a meeting to be held on the Lord's day, and as we regard Sunday desecration one of the most degrading sins of our day and state, we decline to attend the said meeting ourselves, and deem it improper to announce the fact of such meeting from our pulpits.

"We favor all efforts to increase the spirit of patriotism in this community and land, but refuse to indorse any efforts which involve a trampling upon the religious and patriotic convictions of a large portion of our people. Respectfully yours, Sherman Hill, E. B. Lounsbury, R. H. Shaeffer, G. H. Freese, E. J. Groeneveld."

In regard to this correspondence, Mr. Bray then said: "I was raised in a religious country and I was brought up with deep convictions as to my duty both to my God and my country. It was taught that it was my duty to uphold the rights of my creator and also trust love for my country. I do not regard this meeting as any desecration of the Lord's day. I do not believe the day was ever made the day on which we are to arrange for a celebration of America's national day. The day on which Dewey fought for our flag is none too good for us to meet on and arrange to celebrate the day on which the flag was born, and to honor the men who are now fighting the battles of the country. We had no thought to do any injury to the sacred feelings of any people. It seems to me that we favor all efforts to increase the spirit of patriotism in this community and land, but refuse to indorse any efforts which involve a trampling upon the religious and patriotic convictions of a large portion of our people.




