It may be an item of news to the taxpayers of this county that the Board of County Commissioners, at their regular meeting held on Monday, March 5, 1923, have been considering plans and specifications for the erection of a court house and jail.

The law makes this a question upon which the people are to be consulted. The Board of the fifth division of general law, fourth division, empowers county commissioners to "borrow money on the credit of the county, in any amount not exceeding \$100,000, for the erection of a court house and jail."

Section 240 says: "The Board of County Commissioners shall not borrow money for the purpose specified in the fourth section of article 316 of this constitution without first having submitted the question of such loan to a vote of the electors of the county."

The law very clearly implies that, in the expenditure of a sum of such magnitude as the erection of county buildings, the tax-payers must be consulted. That this provision of the law is the purpose of the present election is manifestly apparent.

The ladies of the Methodist church will give one of their pleasant socials at Good Templar's building on Wednesday evening. All are cordially invited.

The postoffice at Naples on the Wood River road was broken into last Friday night and robbed of all the registered letters, money and stamps there were in the office.

It is reported that the proposed court house and jail are to cost only \$100,000, but those who know anything about the matter will tell you that they will cost twice that amount before completed and furnished. If the county commissioners will permit their own hands to be put on the job, the building will cost \$200,000.

A Kidnapper Kidnapped. In the District Court yesterday a decree was granted dissolving the bonds of matrimony heretofore existing between Katy Protzman and Leroy Protzman. The divorce was granted upon the petition of the wife, which sets forth an array of causes for the action, embracing drunkenness, abusive treatment and failure to provide. The defendant failing to appear, judgment by default was entered and the testimony of several witnesses was taken to substantiate the allegations of the petition. After hearing the evidence a decree was ordered to be entered giving to the wife custody of the two children, a boy of four years and a girl of three. Although offering no defense in court the recalcitrant husband was not satisfied with the decree, and threatened dire vengeance upon his wife and children, court, attorneys and all connected with the legal proceedings. As an initiatory step in his scheme of revenge Protzman visited the residence of his former wife yesterday evening and took both children away. Complaint was made at police headquarters, and Officer Carroll was detailed to arrest the kidnapper. He was found with the little boy in a saloon, and talked about bloodshed when the officer demanded to know what he had done with the girl. He was finally compelled to disclose the whereabouts of the child, who was subsequently found at one of the lowest dives in the city, in bed with the scariest woman who keeps the place, and who said that Protzman had given her the child to raise as her own. The seed who was willing to consign his own offspring to such a fate, was present and did not deny the woman's story. He was placed behind the bars where he will be held to answer the charge of kidnapping, and probably to serve out such term of imprisonment as the district court may impose as a penalty for his high handed conduct of his judicial duty. The children were returned to the custody of their mother.

The mad news was brought to C. S. Shonemaker last Saturday of his brother's death in the canyon. Although the information had just reached Mr. Shonemaker, the accident occurred a month ago. On February 12th, Eliza Shonemaker, wife of the late C. S. Shonemaker, was driving to her home, and was overtaken by a car coming from the east. She was struck and killed instantly, but notwithstanding the terrible wound, she managed to crawl three miles to the house of a neighbor, where she died about twenty-four hours after the accident.

From the Daily of Tuesday. COUNTY BUILDINGS.

It may be an item of news to the taxpayers of this county that the Board of County Commissioners, at their regular meeting held on Monday, March 5, 1923, have been considering plans and specifications for the erection of a court house and jail.

The law makes this a question upon which the people are to be consulted. The Board of the fifth division of general law, fourth division, empowers county commissioners to "borrow money on the credit of the county, in any amount not exceeding \$100,000, for the erection of a court house and jail."

Section 240 says: "The Board of County Commissioners shall not borrow money for the purpose specified in the fourth section of article 316 of this constitution without first having submitted the question of such loan to a vote of the electors of the county."

The law very clearly implies that, in the expenditure of a sum of such magnitude as the erection of county buildings, the tax-payers must be consulted. That this provision of the law is the purpose of the present election is manifestly apparent.

The postoffice at Naples on the Wood River road was broken into last Friday night and robbed of all the registered letters, money and stamps there were in the office.

It is reported that the proposed court house and jail are to cost only \$100,000, but those who know anything about the matter will tell you that they will cost twice that amount before completed and furnished. If the county commissioners will permit their own hands to be put on the job, the building will cost \$200,000.

Thomas Hunt, Louis Raymond and Martha Gallagher were taken to the asylum at Warm Springs by Sheriff Irvin on Sunday. They are all suffering from various forms of dementia.

The Governor, President of the Council and Speaker of the House met at a conference committee on Saturday and decided that only seventy-four bills and resolutions of the entire number passed should be printed.

Miss Hamilton & Doremus have opened a commission and produce store one door east of the Grand Central hotel, Broadway. They propose to keep on hand a supply of butter, eggs and other supplies for family use, and will be pleased to receive a share of public patronage.
