Mining Notes.

Yesterday was pay day at the Anacosta, Lexington and Belle mines.

The total bullion shipments last week amounted to \$71,724, of which the Alice shipped \$24,884, Lexington, \$19,025, Anacosta, \$1,052, First National Bank, \$11,672, Donnell, Clark & Larrabee, \$400.

After a thorough overhauling the Moulton mill started up last Wednesday for another long run.

The mine is looking well, particularly in the west drift from the 300 foot cross-cut, where some very fine ore is being extracted.

Work on the new three-compartment shaft at the Bell is progressing very rapidly, three frames, or fifteen feet per day, being the average advance.

The contractor is under agreement to reach the 400 foot station in 100 days, when connections will be run with the old workings and the mine explored and developed below.

The eighty stamps of the Alice mill have been dropping with their accustomed regularity during the week, and to a good purpose as to produce the large shipment of bullion shown in our tabulated statement.

The properties are all looking well, and barring the accident to the baby hoist at the Magna Charta, operations since our last report have moved like clock work.

An erroneous impression prevails that the breaking of the reel at the Magna Charta caused a suspension of work in the entire mine.

The work of sinking the new pump compartment, only, was interrupted, and the usual amount of ore is being hoisted to the mine.

The Shoulter shaft has reached a point fifty feet below the 150-foot level.

The steps of the east 150-foot drift are showing up better than ever, and the mill returns last week forty per cent, better than in any previous week since the mine became a producer.

The first work in the Shoulter was commenced one year ago last Thursday. During the year \$30,000 has been expended in improvements and machinery. The mine is now ramping at a profit.

The location of the Anacosta mine for is still an un-solved problem.

Superintendent Daly is now in San Francisco, and it is thought he will be decided before his return.

Two Children Burned Alive.

A Misoula dispatch says: On Saturday morning last at St. Paul's school, two miles up the canyon, two children of Mr. and Mrs. W. G. Starks—a girl of six and a boy of three—were burned to death.

There was a cabin and two tents. Mrs. Starks went out to the tent to get breakfast leaving the children in bed. It is supposed a spark flew out of the stove and ignited the bed.

When discovered the fire had such headway that the children could not be reached and they were charred until unrecognizable. The Odd Fellows of Misoula took charge of the funeral.

A. O. U. W. Items.
