BIG MINING SALE.

The Phil Shenon Property Purchased for \$175,000 by English Capitalists.

BUTTE, September 18.—[Special.]—The Phil Shenon mines in Beaverhead county were sold yesterday for \$175,000 to an English syndicate. Sixteen full claims comprise the group, the principal one of which is the Golden Leaf, upon which a ten-stamp mill has been erected, and which has yielded large returns, notwithstanding the faulty construction of the mill and the inadaptability of the method of reduction employed.

The purchaser of the ground is the Carlisle Gold Mining Company, of London, England, and first payment was made yesterday and deeds placed in escrow with Clark & Larabee.

Mr. J. Stewart Wallace, one of the directors of the company, acted as its agent in purchase, and Mr. W. N. Symington, of New York, and Mr. G. B. Eustice, manager of the company's works at Carlisle, made the examination and report upon which sale was consummated.

A FINE PORTRAIT.

Ex-Governor Hauser Presents T. H. Kleinschmidt with a Picture of Himself.

One of the best oil portraits ever seen in Helena is temporarily displayed in the directors room of the First National bank. It is a life size picture of Hon. Theodore H. Kleinschmidt, the able, affable and popular assistant cashier of the First National bank. It represents that gentleman standing, attired in business clothes, with one arm resting naturally upon a table. The position, figure, face and all are a life-like reproduction of the original, and the faithfulness of the likeness, together with the fresh, clear and healthy details of costume, etc., reflect great credit on the artist. The figure stands out from the canvas in most realistic manner and appears as if Mr. Kleinschmidt himself were standing in the massive gilt frame. The portrait is from the brush of Mr. A. D. Cooper, the young Helena artist, who is a cousin of Mrs. S. T. Hauser, and is one of his best works. It was painted by order of Ex-Governor Hauser, who, out of regard for Mr. Kleinschmidt, who has been a faithful officer of the First National since it commenced business in 1866, and as a token of his esteem had the portrait made for presentation to Mr. Kleinschmidt. The ex-governor said to-day that it was the best portrait he had ever seen and that he intended to present it to Mr. Kleinschmidt as soon as the people who visited the bank got through admiring it. Granite Water Works.

[Philippus Mail.]

A company to be known as the Fred Burr and Granite Ditch company has been organized in Granite recently for the purpose of supplying the town of Granite and vicinity with an abundance of water.

W. C. Baskett, W. S. Dodds, J. H. Henley and A. J. Bettles are the incorporators, with Mr. Baskett for president. The water will be conveyed from Fred Burr lake and the north branch of Fred Burr creek, a distance of four miles to Granite, giving a fall of 300 feet in the four mile distance. Two tanks with a capacity of 12,000 gallons each, will be built at the point where the flume comes in, and the fall from there to the town will be increased 200 feet more, giving sufficient power to supply every house with pure water, and always have a surplus hand in case of fire. Soon after the laying of the pipes for supplying the town, a fire department will be organized, thereby reducing the rate of insurance and making it possible to insure. The capital stock is \$50,000, divided into 10,000 shares.
