FARMS AT AUCTION SALE.

WILSALL, Mont., Sept. 2.—S. O. N. C. Brady, president of the Brady-Collins Sheep company, of Helena, announces that that company and the Winchell Springs Land company of Great Falls, Montana, will sell 54 farms at auction at Geraldine, Mont., September 29, the farms consist of from 80 to 320 acres. Geraldine is on the Milwaukee railroad between Great Falls and Lewistown. The sale means the opening of a fertile territory for agriculture in the state and is another instance of the passing of large number of sheep which are compelled to give way to agriculture. Mr. Brady said that the companies find it necessary to sell the land because of the rapid settling of the section, making it impossible to graze sheep in the future in that vicinity. The land is situated within a radius of four miles, with one exception, and is right at Geraldine, a growing town.

FOURTH AVENUE WILL BE PAVED

NEW DISTRICT EXTENDING FROM JANEUX TO WATER, IS CREATED.

BUSY MEETING OF CITY COUNCIL

Fourth avenue south will be paved from Janeaux to Water street, the final resolution creating this paving district being passed at the council meeting held Monday evening, as there were no protests against this improvement. A number of other matters relating to improving the streets in various parts of the city and the repairing and building of sidewalks occupied the time of the council, and last night's meeting was what might be called an improvement session. However, a large list of routine business came up for transaction and the session was a very busy and long one, not ending until after 11 o'clock. Those Present. Mayor Symmes presided, Aldermen d'Autremont, Vestrom, Smith Sutter, Miller and Mathews were present, thus presenting the full personnel of the council. Street Flushing. The council decided to advertise for bids for the street flushing. This will be done by contract hereafter, instead of by day labor. Police Matron. A discussion of the duties and the work of the police matron took place. It was decided to retain her services, subject to the wishes of the council. Streets and Sidewalks. A number of improvements on the streets, such as grading, new sidewalks and repairs in various parts of the city were ordered. The council ordered cross walks to be put in along Sixth avenue and also across that street wherever required. The street and alley committee will go over the street this morning to finally pass on these improvements. The water and sewerage committee was given power to act in removing some 20 loads of rock on Water street, left when the sewer was put in. Paul Trigg addressed the council regarding Sixth avenue. This street will be dragged and put in the best of shape, while cement sidewalks were ordered in on the east side of the street. Sixth avenue now ranks as one of the best graded gravel streets in the city. R. von Tobel called attention of the council to the defective condition of the walk leading up the hill to the high school on Water street. The committee will investigate with power to act. John Knudson suggested that Watson street be paved from Third to Fifth avenue. The mayor stated that he had carefully inspected the street, especially where the paving abutted on the gravel streets, and that at these points there was a "bump-off" place, which needed filling in. The engineer was instructed to remedy this. Refuse Extension. The application for a water extension of Mr. Elton in Sunnyside addition was refused as the income would not be 20 per cent, or even a fourth of that. The Bathhouse. Chairman d'Autremont of the park committee reported that with the beginning of school, Professor Robinson could not be in attendance at the bathhouse except from 4:30 to 7 p. m. during week days. The method of running the bathhouse until September 15 and the care of the city park was referred to the committee, with power to act. No Change. The matter of the grade along Broadway street, where sidewalks have just been ordered in, came up for consideration when Mr. Van Horn of the Carpenters' union asked for a change so that the walk could be put down to the street grade along their lot. The grade had been fixed, after careful consideration, it was reported, and no change would be made. License Collection. City Attorney L. B. Kirkland reported that he had seen the 38 or 39 delinquents for license fees and that all had paid except two, against whom actions have been filed. The auto dealers had not paid, however, as they protested on the ground that the fee is too high. A resolution passed by the Lewistown Auto Trades association was read. It set forth that in its opinion the \$10 per quarter fee was too high, that inspection was not required and that they would engage an attorney to represent them in a test case, if the city tried to force collection of this amount. Referred to ordinance committee to confer with the auto dealers. A new license ordinance is now in process of preparation. Clerk's Bond. The bond of Harry Piton as city clerk was reduced to \$1,500, while his bond as water clerk was increased to \$3,500. Want Information. The Missoula city clerk addressed the council, asking for information regarding the special improvement district bonds used by Lewistown, as he had heard that they were models. Referred to city attorney. City Must Pay. The city must pay the April, May and June tax under the compensation law, for employees in the service of the city. The amount is \$145.50. New District. An ordinance was passed creating Montana street improvement district, for boulevarding purposes. This extends from Seventh avenue to the Milwaukee tracks. Sprinkling District. A resolution was passed establishing the sprinkling district. Defective Work. The contracts of L. W. Schrueth in the Seventh avenue and Broadway special improvement districts were reported to have been completed by the city. Bills for same were submitted and will be sent to the American
