

COUNTY UNION A. S. OF E.

Continued from first page.

Section ten was read and its adoption moved and seconded. After thorough discussion the resolution was adopted.

Moved by Albert Cox and seconded by J. L. Miller that hereafter the county union meet behind closed doors. At this juncture a motion to adjourn prevailed.

At 9 o'clock Saturday morning the meeting was called to order by President Stevens. A roll-call showed twenty-five locals present. An estimate of the membership and locals showed 844 members in good standing and 37 active locals with prospect for a greatly increased membership and five locals. After roll-call, Mr. Cox called up the resolution providing that the County Union meet behind closed doors. The vote resulted in favor of the motion.

Moved by D. Ford and seconded by E. L. Withers that the resolution providing that the committee on co-operative Telephone System be continued with power to appoint sub-committeemen, be reconsidered. After thorough consideration, the vote resulted in favor of the motion.

Moved by J. F. Barnes and seconded by J. W. Sanderfer that the chairman appoint committees in various localities where telephones are wanted. After thorough consideration the motion was adopted.

The Secretary by the consent of Chairman read a communication from Mr. J. C. Whalin of Butler county, relative to regulating freight rates on Green river. Moved by E. E. Durbin and seconded by E. W. Jackson that we consider the matter. Motion carried.

On motion it was ordered that the recommendations of Butler county Union with reference to the regulation freight rates on Green river be adopted by this union.

Moved by Albert Cox and seconded by E. E. Durbin that the delegates to the State Union at Elizabethtown, April 15th, be instructed to present a resolution providing that the State Union meet behind closed doors. Motion carried.

E. W. Jackson offered the following resolution which was read:

The Finance Committee that is now elected or that is to be elected for the ensuing year to be re-elected by the County Union, so their terms will be one, two and three years. Said committee to be as near equally divided as possible and by virtue of the office of the County President he shall be chairman of this committee. This committee shall at their first meeting after this County Union, provide means for drawing for their respective positions.

This committee shall elect one of their number for Secretary. He shall keep a complete record of all business and report at each County Union meeting and shall issue certificates of attendance which shall be countersigned by the President before collection. Their compensation shall be \$2.00 per day.

The President and three members shall constitute a quorum. Said committee to be elected at the regular April meeting of County Union.

Action on same was deferred until afternoon.

Moved by Albert Cox and seconded by J. H. Ambrose that hereafter the proceedings of the County Union be not published. Motion carried.

Moved by Melvin Stewart and seconded by B. L. Withers that the stock committee be empowered to employ some one to ride over the county to work up shipments of stock, and that stock pooling pledges be issued and placed in the hands of the local unions. Motion carried. On motion it was ordered that we adjourn until 1 o'clock.

At 1 o'clock p. m. the body convened. Moved by Ainey Tichenor and seconded by Sam Shields, that we take up the consideration of the Wool question at this time. Moved by E. C. Baird and seconded by T. F. Tanner that the delegates to the called meeting of the State Union call a meeting of the wool growers of Ohio county immediately after the State Union meeting. Motion carried.

Moved by E. W. Jackson and seconded by George Neighbors that the resolution offered before noon providing for the perpetuation of the Finance Committee be adopted. The vote on the motion resulted in the defeat of the motion.

Moved by T. F. Tanner and seconded by E. W. Jackson that the Finance Committee be allowed to report. Motion carried.

Whereupon D. Ford reported that the committee had made a satisfactory sale of all pooled tobacco and that over a million pounds had already been delivered under the contract of

sale and that the committee has collected approximately \$785.95 out of sales of tobacco of the 1908 crop, out of which expenses were paid leaving a balance of approximately \$500 in hands of the Finance Committee.

On motion it was ordered that the chairman appoint a committee to settle with the secretary and treasurer. Whereupon T. F. Tanner and D. Ford were appointed.

On motion it was ordered that the body proceed to the election of a Treasurer.

It was decided that the selection should be by election. Whereupon D. Ford was nominated and on motion was elected by acclamation.

At this juncture President Stevens reported orally his success as committee to reorganize locals in this county. He reported that he had during February and March visited locals in the southern and western part of the county with good success and had had many calls that he was unable to fill.

Moved by Sam Shields and seconded by Warren Taylor that the Secretary be authorized and directed to issue timber pooling pledges in accordance with resolution previously adopted.

On motion it was ordered that William Flener be allowed \$1.50 as services for cleaning the court house and providing fires for the meetings of the County Union.

Moved by T. F. Tanner and seconded by J. H. Ambrose that the ratification of the Finance Committee be made at this and subsequent April meetings of the County Union. The vote resulted in the defeat of the motion.

Moved by Warren Taylor and seconded by William Lake that the county union recommend to the several magisterial district unions that have not already elected members of the Finance Committee, to do so at their next regular meeting. Motion carried. On motion it was ordered that the body adjourn to meet the first Friday and Saturday in July.

ballot box, and never had the stub detached from them, could be counted by the Court, although not counted by the officers of election.

I am inclined to the opinion that by reason of the failure of the officers of election to receive the ballots in question, detach the stubs and place them in the ballot box that there has been no legal election held in the precinct on the question whether or not cattle or any species thereof shall run at large. Being of that opinion, the judgment and order of Court will recite that no election was held on that question; that the attempted election was void. It will then give to the good people who live in that precinct the right to have another election on that question whenever they may elect to do so.

I am further of the opinion that each party to this lawsuit may pay his own cost, and a judgment to that effect may be entered.
