THE DOCTOR IS RIGHT.
 One of the physicians of the city has taken us to task about the treatment of the matter of contagious diseases by the weekly press. After some deliberation we believe that he is right in his position that it is better for the press to tell the whole truth regarding such matters. It discourages the physician from doing his duty and places a premium on the doctor who tries to cover such cases and thus endanger the lives of the community. The physician in question states that in his opinion it would be much better for a town to acquire the reputation of the strict enforcement of quarantine regulations be known as a city where such diseases are lightly treated, where the facts are covered up and the quarantine regulations are not observed. The truth is that a mild form of small-pox is prevalent over the state. Hardly a county has escaped it, but at the same time the disease has proven fatal only in the rarest instances. At Carroll we are informed that there have been five cases, in Vail one, in Stockholm township a number and in half the towns about us there have been one or more cases. Denison has not escaped. There have been two cases both of which are under strict quarantine. The two patients are doing well, at no time has the disease developed alarming symptoms, but there is no question but that both had a mild form of the disease. This is the truth about Denison. Will other towns now be as frank in their statements as to public health? For ourselves we have little fear of the disease and have much more dread of diphtheria and kindred diseases.

Dr. J. J. McWilliams, of Charter Oak, was among the many witnesses in attendance during the trial of the case of Charter Oak vs. Lang. The doctor tells us that he had all arrangements made to attend the inaugural ceremonies at Washington, but that there is so much sickness in his vicinity that he does not feel able to get away.
