



DEATH OF JOHN SIEVERS.

A Useful Life Ended.—Many Loved Ones Left to Mourn.

We regret to chronicle in this issue the death of Mr. John Sievers. Mr. Sievers was the father of our well-known merchant, Mr. Claus Sievers, whose recent death is still a source of sorrow to this community.

Mr. Sievers was born February 8th, 1824, at Theiler, on the Elder in Schleswig, Holstein. One daughter, one stepson, 11 grand children, mourn his death.
