Fire in M. E. Church.

Wednesday night at the M. E. church a fire broke out in the basement which had it not been extinguished before it gathered more headway, would probably have caused serious damage if not totally destroying the church. While the service was going on the church began filling with smoke but no particular attention was paid to it as it was supposed to come from one of the furnaces. Finally the floor grew warm where R. A. Romans was sitting and he went down to see about it and found a small blaze where the chimney of one of the furnaces passed through a partition into one of the class rooms to the main chimney. The wood partition around the chimney was unprotected from the heat while the pipe was propped up with a wooden block. 
