

ANNUAL CONFERENCE

Of The Swedish Free Mission Young People's Society.

HELD AT MADRID LAST WEEK

Nearly One Hundred Young People in Attendance, Including Many From Kiron.

Published by Request.

The following write up of the Free Mission Young People's Society held at Madrid (Kironites we copy from the Madrid News, and which will be read with interest by a number of our people.

The Young Peoples Society of the Swedish Free Mission in Iowa, held their 2nd annual conference in the Swedish Free Mission church at Madrid, Iowa, from Sept. 2nd to 5th.

The meeting was a success from the beginning to the end. The young people of the local society in this town and vicinity entertained all their guests, of which there were at least one hundred, in the most satisfactory way.

The church which will seat between 300 or 400 people could not hold the crowd which on Saturday night and Sunday may have reached up to nearly 500 people, therefore a canvas was stretched from above the windows all along the north side of the church over a temporary built platform with chairs; and through the open windows every word from the inside could be heard.

Two tents were put up on the church ground under the beautiful shade trees in which dinner and supper was served free of charge, during Saturday and Sunday and of which not only the students but every one on the ground was invited to partake. This gathering and "having all things common" showed the most Christian spirit and seemed as an echo from the first church at Jerusalem.

As this Young People's Society is only two years old and none are accepted except those that can give evidence of life in Christ, and as the church to which it belongs is not a popular one in the world the success of the society must be considered all the more wonderful. Then if we add that the language used in all the young people's services is all together their mother tongue, their success is still more remarkable; but it seems that the more of the true heart religion the young people have the more they love to worship in the mother tongue although they are more educated in the English language. Exceptions from this are of course those that never learned Swedish.

The programs during the meeting were as follows: The meetings opened on Friday evening with singing and prayer. The organist during the whole conference being Miss Eda Carlson from Boone, Ia., who is a splendid singer. After prayer a welcome address was given in behalf of the Young Peoples Society at Madrid by Ernest Johnson and another one in behalf of the church by its pastor. After this the so called conference sermon was preached by Rev. N. Wickstrom. His topic being "Our Perfections in Jesus Christ," indeed a suitable topic for young people. The business part of the conference opened on Saturday at 10 a. m. A review of the society's work was given by the present chairman, Rev. A. P. Ljungberg of Boone, Iowa, after which new officers were elected for another year, and by the proposal of the ministers, all ministers were excluded from office.

At 2 p. m. Mrs. Nelson of Boone, Ia., gave an interesting speech about how to get the young people more interested in the Christian work after which Rev. Oscar Dalberg from Boone, who was an invited guest at the conference, delivered an able and excellent oration. His topic being "How a Christian should be in his relation to the world." After this Rev. C. F. Fredrickson of Albert City, Iowa, spoke on the subject, "How the young should best be prepared for the responsibility of the work, when called to step in the path of the old." His exhortations were good and going home to the hearts.

In the evening at 8 o'clock two excellent sermons were preached by Rev. C. M. Anderson from Centerville, Ia., and Rev. C. Hedlund from Beresford, South Dakota, and former pastor of this church. After the service Rev. Hedlund had to leave for Stratford, Ia., on account of the death of a near relative at that place.

Sunday was religiously the most glorious day. With sermons at 10 a. m., 2 p. m. and 7:30 p. m. The officiating ministers during the day, and in order as follows, being Rev. Albert Bostrom, traveling missionary in Iowa and Rev. A. P. Ljungberg of Boone, Ia., in the morning; Rev. E. Lundstrom of Des Moines and Rev. C. W. Ickelander, missionary from India, who talked upon that mission in the afternoon and L. Anderson, student from the Free Mission college and seminary in Chicago, Rev. C. F. Fredrickson and Rev. N. Wicksell from Kiron, Ia., in the evening. All preached with power and the influence during all the meetings were good.

On Monday a picnic with lunch was arranged by the young people of this place and a good speech was made by Rev. N. Wickstrom. Full of points and good advice. The singing was very good during the meetings and songs were sung as only Swedish songs of Swedish voices can be sung and which have to be heard to be realized. There was also a string band consisting of violins guitars and mandolins played by some of our young people and led by Mr. Conradson and they gave us great pleasure during the meetings on Sunday. Our hope is that they will do so also in the future.

The board of officers elected for the coming year was E. E. Clauson, Kiron, President; Albert Anderson, Albert City, Ia., Vice-president; A. Holm, Marathon, Treasurer; A. Recken, Boone, Secretary; Ernst Johnson, Madrid, Vice-secretary.

WAGE EARNERS AT THE FAIR

Prominent Men Planning to Help Workers See the Great Exposition.

Wage earners of America are to see the World's Fair by tens of thousands under the auspices of the National Civic Federation. A new bureau of the Federation has just been established at St. Louis upon the World's Fair grounds. Back of the movement are Grover Cleveland, David R. Francis, Andrew Carnegie, Cornelius N. Bliss and others. Plans are making to have a vast number of the wage earners of the United States see the World's Fair, the most glorious spectacle of the age and the most influential factor in the education of the American citizen.

The bureau is in charge of Miss Gertrude Becks, secretary of the Federation's welfare department, of which Mr. H. H. Vreeland, head of the street railway system of New York city, is chairman. The bureau headquarters is in the east end of the Palace of Transportation, on the ground floor. The Exposition management is in hearty accord with this movement on the part of the Federation to induce the large manufacturers and other employers of labor to provide ways and means for the wage earners of America to visit the Exposition. President Francis is displaying personal interest in the undertaking by affording the Federation every facility for the consummation of its efforts, and in this connection he has directed Theodore Hardee, assistant to the secretary, to co-operate with Miss Becks and Ralph M. Easley, chairman of the Federation's executive council, in every possible way.

The Exposition management has also equipped this bureau with clerical assistance and a full supply of World's Fair literature. The bureau will be used as headquarters for all wage earners coming to the Exposition under its auspices. The aim of the Federation is to make it feasible for the largest possible proportion of wage earners to visit St. Louis and see the World's Fair. It will see that they are met at the depot by responsible persons and conducted to suitable lodgings, where they will be treated fairly.

There will also be furnished, free of charge, appropriate itineraries indicating the points of interest to be seen within a limit of one week, which is about the average time each party will spend here. It will also indicate the objects of special interest to various craftsmen in their particular lines, so that they may devote as much time as possible to the objects of peculiar interest to them. These and many other efforts will be made to help all wage earners to enjoy the benefits of this great Exposition comfortably and at an expense within their means.
