A BUNCH OF BEGGARS.

We have received a second invitation to subscribe to the campaign fund of the 10th District of Iowa, Republican Congressional Committee. B. J. Price of Fort Dodge is chairman of the committee, the chief and only object of which seems to be to extort money from the postmasters of the district. If the 10th district of Iowa needs a fund to elect its congressional candidate, it is time for the republicans of the district and of the entire country to lay down. The state chairman does not approve of the course of this fake committee. It is giving no assistance to democratic counties. It is simply a sponge to absorb the sinews of war and give nothing in return. It is sending out no speakers, it is sending out no literature, except begging letters. Heretofore it has been the custom for Congressional candidates in this district, as in others, to contribute to the campaign funds of the state and of the various counties. This year the policy seems to be reversed and the various counties are called upon to aid the congressional candidate. Of course in former years the primary expenses were not so heavy. Mr. Price who stars as the head of this fake committee, the only business of which is to beg for funds, is an irresponsible politician of the Kelz type to whom no funds should be entrusted for campaign purposes. We believe in campaign contributions and our record is straight in this regard but we have no money for Mr. Price and his fellows.

TO IMPROVE OUR SCHOOLS.

The people of the county have an opportunity to do themselves a good turn by the election of Prof. W. C. Van Ness as county superintendent. He would make an ideal superintendent. The many young people who have received their education at his hands and who know him well ought to rally to his standard all over the county and if they do D. N. C. will be greatly honored. Prof. VanNess is not making an active campaign but he would like to be elected and he assures us that he will appreciate every vote he gets and every bit of help that is given him by his former pupils and his friends throughout the county. It is a good time for the friends of this faithful and efficient educator to come to his aid. For years he has been the life of Denison college and he has seen some pretty hard sledding in his capacity as president. The election to the superintendency would be a fitting recognition of his good work and we know that Prof. VanNess would greatly appreciate it. Without any reflection on Supt. Hoffman, do you not think he has had enough, and do you not think it would be an improvement to have our schools under the direction of a man like Prof. Van Ness. There is no politics in it, just common sense and good judgement. Vote for Van Ness.

For twenty odd years John Carey has held office. When he was not in office he was running for office. Is it not time that some one else was given a chance? What has he done to merit such great distinction at the hands of the people? What has he done for Denison except to open a skating rink which is at best not an unmixed blessing? Of course it will seem rather strange for John not to be either a candidate or an office holder, but we have every confidence that he would get over it and bob up serenely at the next election ready to be "forced" to run.
