Incorporation Notice. We, the undersigned, George W. Nicholson, B. Y. Nicholson and A. E. P. Rouze, residents of the City of Denison, Crawford County, Iowa, for the purpose of organizing the business hereinafter described, do hereby organize ourselves into a body corporate, under the provisions of Chapter 1, Title 9, of the Code of Iowa 1897, and do hereby adopt the following Articles of Incorporation:

SECTION 1. The name of the Corporation shall be "NICHOLSON PRODUCE COMPANY," and its principal place of business shall be at Denison, Crawford County, Iowa.

SECTION 2. The business of the Corporation shall be the buying, selling and handling of butter, eggs and poultry; the operation of a cold storage plant and the manufacturing, handling and selling of ice.

SECTION 3. The authorized capital stock of the Corporation shall be Sixty Thousand Dollars (\$60,000.00), to be divided into shares of One Hundred Dollars (\$100.00) each, all of which shall be paid in cash, or its equivalent, prior to the commencement of business, of the Corporation.

SECTION 4. The business of the Corporation shall commence on the first day of January, 1909, and continue for the period of twenty (20) years thereafter.
