ICE SITUATION IN DENISON

Denison is now experiencing a famine in ice, due entirely to the railroad strike and shortage of coal at the Nicholson Ice & Produce company's plant, which manufactures the ice that supplies the community. Owing to the strike of railroad employees no freight has been moved on the Northwestern since Saturday and the Nicholson plant with only a limited amount of coal on hand has been forced to discontinue the manufacture of ice to conserve the coal on hand to keep the coolers in the big storage room in operation where the produce is in storage. The ice department was closed down yesterday and not a pound is being manufactured at the plant. It is believed that the plant will be able to resume operations.

Residents of Denison are incensed over the raise in the price of ice which went into effect last week when the price was boosted from \$7.00 to \$9.00 per thousand pounds, a price which is almost prohibitive. When the announcement was made last week of this advance in price the Review took the pains to ascertain what it is being retained for in other towns. The Council Bluffs manufactured ice is delivered to the consumer for \$6.00 per thousand pounds; at Ida Grove manufactured ice is delivered to the consumer for \$7.00 per thousand pounds; at Carroll natural ice is sold to the consumer for \$6.50 per thousand pounds, and at Jefferson manufactured ice is sold to the consumer for from \$6.50 to \$7.00 per thousand pounds, according to the quality, and two thousand pound cards are sold at the rate of \$7.00 per thousand with a discount of 5 per cent for cash. Inquiries have been sent to other places but reports have not yet been received, but these prices will be given in the Review next week.

People of Denison have reason to demand why the price here is so much higher than at Council Bluffs and the other towns mentioned above. Certainly the cost of manufacturing is no greater than at these other places and upon the face of it gives every indication that some one is profiteering and some investigation should be made.

The Nicholson Ice & Produce company is a corporation, half of the stock, so we are advised, being owned by Denison people, the other half by the Armour Packing company. The Armour company, since the death of B. Y. Nicholson, have managed the plant. We are advised today that the local stockholders who are members of the board of directors will call a special meeting, at which time they will go over the ice situation with the Armour interests and see if the price can be reduced.

Now that the government has announced that all profiteering will be vigorously prosecuted, we believe it is high time that our local men who are directors make a rigid investigation for they may find themselves in an embarrassing position and faced with government prosecution.
