LETTER FROM WILLOW CREEK.

WILLOW CREEK, M. T., Sept. 27, 1878.

Editor Avant Courier:

Having seen several incorrect accounts in the papers regarding the atrocious murder of W. E. Fredricks, and wishing the readers of your Journal to be truthfully informed, I send you the following facts: The Sunday of the murder, Friday was traveling toward Willow Creek from Mud Springs, by a man who was stock hunting, but whom he avoided, by leaving the road, but who was within fifty yards of the house and then laid in ambush behind some bushes until he saw Mr. F. go to the corral. He then ran rapidly toward the house and entered, having his gun ready and a cartridge in his hand, with several others in his belt, and a butcher knife, also. Passing into the sitting-room where Mrs. Fredrick, was ordered her to give up her money or she would kill her instantly, remonstrating, "I will give you two seconds to get your money, and then I'll kill you anyway." Mrs. F. requested him to have patience and not kill anyone, for as soon as she could get the key of her trunk she would give him what money she had. During this time, Gilbert, Mr. F's little six-year-old son, ran out of the house and told his father that Policy was there. Mr. Fredricks proceeded to the house, and when he saw the man, he stepped, Policy turned, and seeing him reach for his rifle, this desperate man of the house, raised aim and fired, the ball entering his side, passed through the stomach and out of the back. Mr. F. sprang forward, caught him and threw him to the floor, twisting the gun from him. In doing so, the stock struck the side of the wall and was broken. The prisoner was slightly scratched on the face and had some scalp wounds of no consequence. A ball had passed through the shirt shoulder of his coat from a small six inch Colt's pistol, but it took no effect on his body. He told me that he remained in the hills above the mill till eight o'clock that night and then started along the brow of the mountain towards Smith Boulder, which he reached Monday, at 5 p. m. After getting dinner, he proceeded to the Jefferson and crossed, going to the ranch of Mr. Cardwell, where he remained until Tuesday morning. Here he sold his gun, saying it had been broken by a wagon running over it. From this place he proceeded to Fish Creek, stopping at the house of Mr. Tuttle, where he was when I arrested him. He was tracked by a small grail on his boot which showed very distinctly. Being aware that he was in the house, I rode my horse up on one side so that he could not see me. As I entered he was standing by a window, and I requested him to raise his hands and surrender, which he was slow about doing. I had to repeat this four times. He was trying to get his hand in his pocket and had almost succeeded, when I ordered him to raise it or I would under the painful necessity of killing him. He had a large plug of tobacco in his pocket which I thought was a revolver.
